THE ONLY REQUIREMENT FOR MEMBERSHIP IS A DESIRE TO STOP DRINKING. THERE ARE NO DUES OR FEES FOR A. A. MEMBERSHIP; WE ARE SELF-SUPPORTING THROUGH OUR OWN CONTRIBUTIONS.

A.A. IS NOT ALLIED WITH ANY SECT, DENOMINATION, POLITICS, ORGANIZATION OR INSTITUTION; DOES NOT WISH TO ENGAGE IN ANY CONTROVERSY; NEITHER ENDORSES NOR OPPOSES ANY CAUSES. OUR PRIMARY PURPOSE IS TO STAY SOBER AND HELP OTHER ALCOHOLICS TO ACHIEVE SOBRIETY.

THE TWELVE STEPS

- 1. WE ADMITTED WE WERE POWERLESS OVER ALCOHOL--THAT OUR LIVES HAD BECOME UNMANAGEABLE.
- 2. CAME TO BELIEVE THAT A POWER GREATER THAN OURSELVES COULD RESTORE US TO SANITY.
- 3. MADE A DECISION TO TURN OUR WILL AND OUR LIVES OVER TO THE CARE OF GOD AS WE UNDERSTOOD HIM.
- 4. MADE A SEARCHING AND FEARLESS MORAL INVENTORY OF OURSELVES.
- 5. ADMITTED TO GOD, TO OURSELVES, AND TO ANOTHER HUMAN BEING, THE EXACT NATURE OF OUR WRONGS.
- 6. WERE ENTIRELY READY TO HAVE GOD REMOVE ALL THESE DEFECTS OF CHARACTER.
- 7. HUMBLY ASKED HIM TO REMOVE OUR SHORTCOMINGS.
- 8. MADE A LIST OF ALL PERSONS WE HAD HARMED, AND BECAME WILLING TO MAKE AMENDS TO THEM ALL.
- 9. MADE DIRECT AMENDS TO SUCH PEOPLE WHENEVER POSSIBLE, EXCEPT WHEN TO DO SO WOULD INJURE THEM OR OTHERS.
- 10. CONTINUED TO TAKE PERSONAL INVENTORY AND WHEN WE WERE WRONG PROMPTLY ADMITTED IT.
- 11. SOUGHT THROUGH PRAYER AND MEDITATION TO IMPROVE OUR CONSCIOUS CONTACT WITH GOD AS WE UNDERSTOOD HIM, PRAYING ONLY FOR KNOWLEDGE OF HIS WILL FOR US AND THE POWER TO CARRY THAT OUT.
- 12. HAVING HAD A SPIRITUAL AWAKENING AS THE RESULT OF THESE STEPS, WE TRIED TO CARRY THIS MESSAGE TO ALCOHOLICS, AND TO PRACTICE THESE PRINCIPLES IN ALL OUR AFFAIRS.

THE TWELVE TRADITIONS

- 1. OUR COMMON WELFARE SHOULD COME FIRST; PERSONAL RECOVERY DEPENDS UPON A.A. UNITY.
- 2. FOR GROUP PURPOSE THERE IS BUT ONE ULTIMATE AUTHORITY--A LOVING GOD AS HE MAY EXPRESS HIMSELF IN OUR GROUP CONSCIENCE. OUR LEADERS ARE BUT TRUSTED SERVANTS; THEY DO NOT GOVERN.
- 3. THE ONLY REQUIREMENT FOR A.A. MEMBERSHIP IS A DESIRE TO STOP DRINKING.
- 4. EACH GROUP SHOULD BE AUTONOMOUS EXCEPT IN MATTERS AFFECTING OTHER GROUPS OR A.A. AS A WHOLE.
- 5. EACH GROUP HAS BUT ONE PRIMARY PURPOSE--TO CARRY ITS MESSAGE TO THE ALCOHOLIC WHO STILL SUFFERS.
- 6. AN A.A. GROUP OUGHT NEVER ENDORSE, FINANCE, OR LEND THE A.A. NAME TO ANY RELATED FACILITY OR OUTSIDE ENTERPRISE, LEST PROBLEMS OF MONEY, PROPERTY, AND PRESITGE DIVERT US FROM OUR PRIMARY PURPOSE.
- 7. EVERY A.A. GROUP OUGHT TO BE FULLY SELF-SUPPORTING, DECLINING OUTSIDE CONTRIBUTIONS.
- 8. ALCOHOLICS ANONYMOUS SHOULD REMAIN FOREVER NON-PROFESSIONAL, BUT OUR SERVICE CENTERS MAY EMPLOY SPECIAL WORKERS.
- 9. A.A AS SUCH, OUGHT NEVER BE ORGANIZED; BUT WE MAY CREATE SERVICE BOARDS OR COMMITTEES DIRECTLY RESPONSIBLE TO THOSE THEY SERVE.
- 10. ALCOHOLICS ANONYMOUS HAS NO OPINION ON OUTSIDE ISSUES; HENCE THE A.A. NAME OUGHT NEVER BE DRAWN INTO PUBLIC CONTROVERSY.
- 11. OUR PUBLIC RELATIONS POLICY IS BASED ON ATTRACTION RATHER THAN PROMOTION; WE NEED ALWAYS MAINTAIN PERSONAL ANONYMITY AT THE LEVEL OF PRESS, RADIO, AND FILMS.
- 12. ANONY MITY IS THE SPIRITUAL FOUNDATION OF OUR TRADITIONS, EVER REMINDING US TO PLACE PRINCIPLES BEFORE PERSONALITIES.

OUR TWELFTH STEP--CARRYING THE MESSAGE--IS THE BASIC
SERVICE THAT THE A.A. FELLOWSHIP GIVES; THIS IS OUR PRINCIPAL
AIM AND THE MAIN REASON FOR OUR EXISTENCE. THEREFORE, A.A.
IS MORE THAN A SET OF PRINCIPLES; IT IS A SOCIETY OF ALCOHOLICS
IN ACTION. WE MUST CARRY THE MESSAGE, ELSE WE OURSELVES
CAN WITHER AND THOSE WHO HAVEN'T BEEN GIVEN THE TRUTH MAY
DIE.

HENCE, AN A.A. SERVICE IS ANYTHING WHATEVER THAT HELPS
US TO REACH A FELLOW SUFFERER--RANGING ALL THE WAY FROM
THE TWELFTH STEP ITSELF TO A TEN-CENT PHONE CALL AND A CUP
OF COFFEE, AND TO A.A.'S GENERAL SERVICE OFFICE FOR NATIONAL
AND INTERNATIONAL ACTION. THE SUM TOTAL OF ALL THESE SERVICES
IS OUR THIRD LEGACY OF SERVICE.

SERVICES INCLUDE MEETING PLACES, HOSPITAL COOPERATION,
AND INTERGROUP OFFICES; THEY MEAN PAMPHLETS, BOOKS, AND
GOOD PUBLICITY OF ALMOST EVERY DISCRIPTION. THEY CALL FOR
COMMITTEES, DELEGATES, TRUSTEES, AND CONFERENCES. AND,
NOT TO BE FORGOTTEN, THEY NEED VOLUNTARY MONEY CONTRIBUTIONS FROM WITHIN THE FELLOWSHIP.

THESE SERVICES, WHETHER PERFORMED BY INDIVIDUALS, GROUPS, AREAS, OR A.A. AS A WHOLE, ARE UTTERLY VITAL TO OUR EXISTENCE AND GROWTH. NOR CAN WE MAKE A.A. MORE SIMPLE BY ABOLISHING

SUCH SERVICES. WE WOULD ONLY BE ASKING FOR COMPLICATION AND CONFUSION.

CONCERNING ANY GIVEN SERVICE, WE THEREFORE POSE BUT ONE QUESTION: "IS THIS SERVICE REALLY NEEDED?" IF IT IS, THEN MAINTAIN IT--WE MUST, OR FAIL IN OUR MISSION TO THOSE WHO NEED AND SEEK A.A.

NEVER GET DISCOURAGED IN SERVICE WORK. PLANT THE SEED AND LET THE GOD OR POWER GREATER THAN YOURSELF DO THE BALANCE. ONLY "HE" HAS THE POWER!

DO YOU SOMETIMES WONDER WHAT BECOMES OF THE AA SEEDS WE PLANT IN THE MINDS OF OTHERS. DO YOU SOMETIMES WONDER WHAT BECOMES OF THE SEEDS PLANTED IN OUR MINDS.

IT IS LIKENED TO A SOWER OF SEEDS. SOME OF THE SEED FALLS
ON THE ROAD. PASSERS-BY TRAMPLE SOME OF IT INTO THE DUST
AND THE BIRDS EAT THE REST. SOME OF THE SEED FALLS ON THE
GRAVEL PATCH OR SHOULDER OF THE ROAD. IT SPROUTS QUICKLY
BUT WHEN THE HOT SUN COMES IT WITHERS AND DIES JUST AS QUICKLY
BECAUSE IT WASN'T DEEPLY ROOTED. SOME SEED FALLS AMONG
THE WEEDS. IT GROWS, BUT THE WEEDS GROW MORE QUICKLY AND
CHOKE IT OUT. SOME OF THE SEED FALLS ON FERTILE SOIL AND
BRINGS A GREAT YIELD, ANYWHERE FROM THIRTY TO ONE HUNDRED
TIMES THE AMOUNT SOWN.

THE ROAD MAY BE COMPARED TO THOSE PEOPLE WHO HEAR THE AA WORD BUT HAVE IT SNATCHED FROM THEM BY THEIR OLD DRINKING IDEAS BEFORE THEY CAN ACCEPT IT AND GET SOBER. THE AA SEED THAT FALLS ON THE GRAVEL PATCH OR SHOULDER OF THE ROAD IS LIKE THOSE WHO HEAR THE AA WORD AND IMMEDIATELY AND HAPPILY ACCEPT IT. BUT, BECAUSE THEY ARE SHALLOW, THEY CAN'T ENDURE

TEMPTATION, TROUBLE, OR PERSECUTION AND THEY FADE AWAY.

THE AA SEED THAT FALLS AMONG THE WEEDS IS LIKE THOSE PEOPLE

WHO HEAR THE AA WORD, BUT THE PROBLEMS OF DAILY LIFE, THE

ILLUSORY PROMISES OF WEALTH, OR THE DESIRE FOR MATERIAL

THINGS, CROWD IN AND SLOWLY CHOKE OUT THEIR AA LIFE. SOME
TIMES IT TAKES YEARS FOR THIS TO HAPPEN. THE AA SEED SOWN

ON FERTILE SOIL, HOWEVER, IS LIKE THOSE PEOPLE WHO HEAR THE

AA WORD AND UNDERSTAND IT AND WORK PATIENTLY TO PRODUCE

A GOOD DAILY QUALITY OF SOBRIETY AND IN TIME, DAY BY DAY,

THEY HAVE A BOUNTIFUL HARVEST.

THE PROGRAM OF AA IS SUCH A PROGRAM THAT EACH INDIVIDUAL MUST APPLY THE PRINCIPLES TO HIS OR HER LIFE TO REAP THE BOUNTIFUL HARVEST.

CHAPTER ONE

MEMBER'S RESPONSIBILITY TO OTHER MEMBERS MEMBER'S RESPONSIBILITY TO AA

THE ONLY REQUIREMENT FOR MEMBERSHIP IN ALCOHOLICS ANONYMOUS IS A DESIRE TO STOP DRINKING. OUR MEMBERSHIP OUGHT TO INCLUDE ALL WHO SUFFER FROM ALCOHOLISM. HENCE WE MAY REFUSE NONE WHO WISH TO RECOVER. EACH MEMBER HAS TO CLARIFY HIS OR HER DESIRES. IF AN INDIVIDUAL REALLY WANTS TO GET DRUNK, THERE IS, SO FAR AS AA KNOWS, NO WAY TO STOP HIM. THE CO-FOUNDERS TOLD BILL D., THEIR FIRST SUCCESSFUL TWELVE STEP CALL, THAT AA HAD NO INTENTION OF TAKING THE PRIVILEGES OR RIGHTS TO DRINK AWAY FROM HIM. IF HE THOUGHT THIS THEY WOULD NOT WASTE HIS TIME. WHO OF THE MEMBERSHIP DARE TO BE JUDGE, JURY AND EXECUTIONER OF HIS SICK ALCOHOLIC SISTER OR BROTHER.

IF A ALCOHOLIC SHOWS UP AMONG THE MEMBERSHIP AND SAYS HE

OR SHE DOESN'T LIKE THE AA PRINCIPLES, PEOPLE, OR SERVICE MANAGE
MENT, WHEN HE DECLARES THAT HE CAN DO BETTER ELSEWHERE--WE

ARE NOT TO WORRY. WE SIMPLY SAY, "MAYBE YOUR CASE IS REALLY

DIFFERENT. WHY DON'T YOU TRY SOMETHING ELSE?"

IF AN AA MEMBER SAYS HE DOESN'T LIKE HIS OWN GROUP, WE ARE NOT TO BE DISTURBED. WE SIMPLY SAY, "WHY DON'T YOU TRY ANOTHER GROUP OR START ONE OF YOUR OWN?"

TO THOSE MEMBERS WHO WISH TO SECEDE FROM AA ALTOGETHER,

WE ARE TO EXTEND A CHEERFUL INVITATION TO DO JUST THAT. IF THEY CAN DO BETTER BY OTHER MEANS, WE ARE GLAD. IF AFTER A TRIAL THEY CANNOT DO BETTER, WE KNOW THEY FACE A CHOICE: THEY CAN GO MAD AND DIE OR THEY CAN RETURN TO AA. THE DECISION IS WHOLLY THEIRS.

WE OF AA BELIEVE THERE ISN'T A FELLOWSHIP ON EARTH WHICH
DEVOTES MORE CARE TO ITS INDIVIDUAL MEMBERS; SURELY THERE IS
NONE WHICH MORE JEALOUSLY GUARDS THE INDIVIDUAL'S RIGHT TO THINK,
TALK, AND ACT AS HE WISHES. NO AA CAN COMPEL ANOTHER TO DO
ANYTHING; NOBODY CAN BE PUNISHED OR EXPELLED.

OUR TWELVE STEPS TO RECOVERY ARE SUGGESTIONS, THE TWELVE TRADITIONS WHICH GUARANTEE AA'S UNITY CONTAIN NOT A SINGLE "DON'T". THEY REPEATLY SAY, "WE OUGHT".....BUT NEVER "YOU MUST". WE THE MEMBERS OF AA HAVE ONLY ONE NAME THAT WILL COM-PLETELY REGIMENT US, THAT IS "JOHN BARLEYCORN". THERE WILL THREE ARREST OF BUT DOB. A NEVER BE REGIMENTATION BY ALCOHOLICS ANONYMOUS. EACH MEMBER CONTRACTOR AND A SECURE OF A S CAN NEVER SAY OR INSINUATE TO ANYONE THAT HE OR SHE MUST AGREE TO OUR FORMULA OR BE EXCOMMUNICATED. COME AA MEMBERS BY SIMPLY ASSOCIATING WITH US. NOTHING BUT SINCERITY IS NEEDED. BUT WE DO NOT DEMAND EVEN THIS. IN SUCH AN ATMOSPHERE THE OXTHODOX, THE UNOXTHODOX, AND THE UNBELIEVER MIX HAPPILY AND USEFULLY TOGETHER. AN OPPORTUNITY FOR SPIRITUAL GROWTH IS OPEN TO ALL.

ALL KINDS OF PEOPLE HAVE FOUND THEIR WAY INTO AA. WE OF AA HAVE NO DESIRE TO CONVINCE ANYONE THAT THERE IS ONLY ONE WAY BY WHICH FAITH CAN BE ACQUIRED. ALL OF US, WHATEVER OUR RACE, CREED OR COLOR, ARE THE CHILDREN OF A LIVING CREATOR, WITH WHOM WE MAY FORM A RELATIONSHIP UPON SIMPLE AND UNDERSTANDABLE TERMS AS SOON AS WE ARE WILLING AND HONEST ENOUGH TO TRY.

THERE ARE ALCOHOLICS NOT AS FORTUNATE AS YOU AND I. THEY
WERE CAUGHT AND WERE INCARCERATED FOR ACTS DONE UNDER THE
INFLUENCE OF ALCOHOL. LET US NOT FORGET THAT EVERY AA MEMBER
HAS BEEN, IN A SENSE A PRISONER. EACH OF US HAS WALLED HIMSELF
OUT OF SOCIETY; EACH HAS KNOWN SOCIAL STIGMA. BUT THESE
ALCOHOLICS, SOCIETY HAS BUILT A WALL AROUND THEM. THERE ISN'T
REALLY ANY ESSENTIAL DIFFERENCE BETWEEN THESE AA MEMBERS
AND MEMBERS ON THE OUTSIDE. THEREFORE, WHEN THEY COME INTO
THE WORLD OF AA ON THE OUTSIDE, LET US BE SURE THAT NO ONE WILL
CARE A HOOT THAT THEY HAVE DONE TIME. WHAT THEY ARE TRYING
TO BE--NOT WHAT THEY WERE--IS ALL THAT COUNTS WITH AA.

MENTAL AND EMOTIONAL DIFFICULTIES ARE SOMETIMES VERY HARD
TO TAKE, WHILE WE ARE TRYING TO MAINTAIN SOBRIETY. YET WE DO
SEE, IN THE LONG RUN, THAT TRANSCENDENCE OVER SUCH PROBLEMS IS

THE REAL TEST OF THE AA WAY OF LIVING. ADVERSITY GIVES MORE OPPORTUNITY TO GROW THAN COMFORT OR SUCCESS.

AA, WE WILL REPEAT, JEALSOUSLY GUARDS ITS MEMBERSHIP RIGHTS.

IT EVEN GOES SO FAR AS TO INSURE ITS INDIVIDUAL MEMBER THAT NEITHER

THE AA GENERAL SERVICE CONFERENCE, ITS BOARD OF TRUSTEES, NOR

THE HUMBLEST GROUP COMMITTEE CAN ISSUE A SINGLE DIRECTIVE TO

AN AA MEMBER AND MAKE IT STICK, LET ALONE HAND OUT ANY PUNISH
MENT.

GROUPS HAVE SOMETIMES TRIED TO EXPEL MEMBERS, BUT THE BANISHED HAVE COME BACK TO SIT IN THE MEETING PLACE, SAYING "THIS IS LIFE FOR ME; YOU CAN'T KEEP ME OUT." COMMITTEES HAVE INSTRUCTED MANY AN AA TO STOP WORKING ON A CHRONIC BACKSLIDER, ONLY TO BE TOLD, "HOW I DO MY TWELVE STEP WORK IS MY BUSINESS. WHO ARE YOU TO JUDGE?"

YES, AA DOES NOT DENY ANYONE HIS OR HER CHANCE TO RECOVER FROM ALCOHOLISM. WE OF AA WISH TO BE JUST AS INCLUSIVE AS WE CAN, NEVER EXCLUSIVE.

PRESERVATION OF THE FELLOWSHIP. HE OR SHE LEARNS THAT THE

CLAMOR OF DESIRES AND AMBITIONS WITHIN HIM OR HER MUST BE SILENCED

WHENEVER THESE COULD DAMAGE AA. IT BECOMES PLAIN THAT AA MUST

SURVIVE OR THE INDIVIDUAL WILL NOT.

AA IS MORE THAN A SET OF PRINCIPLES, IT IS A SOCIETY OF ALCOHOLICS IN ACTION. WE MUST CARRY THE MESSAGE, ELSE WE OURSELVES CAN MEMBER STEESPONS BLATTY TO OTHER MEMBER STEESPONS BLATTY BLA

EACH MEMBER COMING INTO AA FINDS A GREATER PERSONAL FREEDOM
THAN ANY OTHER SOCIETY KNOWS. THE NEW MEMBER FEELS HE HAS
TALK ACT AS IT OF THE VISION WITH A MAY NOT SEE AT ONCE THAT
RESPONSIBILITIES TO ALCOHOLICS ANON MOVE
HE HAS BARELY SCRATCHED A LIMITLESS LODE WHICH WILL PAY
REALIZATION DAWNS ON LACE STRUCK OF HIS LIFE AND INSISTS
OF A SIREAT WHOLE, THAT HO PRODUCT.
PRESERVATION OF THE FELLOWSHIP HE HAS SEE LEAFNER THAT

AN AA GROUP WHICH IS MADE UP OF AA MEMBERS IS NOT, FOR EXAMPLE, CLAMOR OF DESIRES AND AMEDITIONS WITHOUT OR HER MADE ALL SILES AND AMEDITIONS, NOR DOES IT FURNISH PERSONAL WHENEVER THESE COULD DAMAGE AND IT ADCORAGE TO A MEAN FINANCIAL AID TO ANY MEMBER. THIS IS WHY SOBRIETY--FREEDOM FROM SURVIVE OR THE INDIVIDUAL WILL MOT

ALCOHOL-THROUGH THE TEACHINGS AND PRACTICE OF AA'S TWELVE
AAA'S MORE THAN A SET OF PRINCIPLES, IT IS A DEPOSITE OF A PROPERTY
AND SET OF THAN A SET OF PRINCIPLE.

STEPS, IS THE SOLE PURPOSE OF THE GROUP. IF WE DON'T STICK TO
THIS CARDINAL PRINCIPLE, WE SHALL ALMOST CERTAINLY COLLAPSE.
AND IF WE COLLAPSE WE CANNOT HELP ANYONE. MORE OF THIS WILL
BE PART OF THE GROUP'S RESPONSIBILITY WHICH WILL BE DISCUSSED
LATER. THE REASON IT IS BROUGHT UP NOW IS TO LET EACH MEMBER
KNOW HOW TO EXPEDITE HIS OR HER EFFECTIVINESS AND ENERGIES IN
THE RIGHT DIRECTION. NO MEMBER IS RESPONSIBLE FOR ANOTHER MEMBER!
DOMESTIC OR FINANCIAL CONDITIONS. THIS IS NOT SATING THAT AN INDIVIDUAL CAN OR CANNOT INVOLVE HIS OR HERSELF IN THESE CONDITIONS
BUT IT IS NO PART OF ALCOHOLICS ANONYMOUS.

THE UNITY OF EACH MEMBER IS THE MOST CHERISHED QUALITY AA HAS. THE MEMBERS LIFE AND THE LIVES OF ALL TO COME, DEPEND SQUARELY UPON IT. THERE CANNOT BE UNITY IN AA AS A WHOLE UNLESS EACH MEMBER TAKES IT ON AS HIS RESPONSIBILITY. WITHOUT INITY, THE HEART OF AA WOULD CEASE TO BEAT. "UNIFIED WE LIVE; DISUNITED WE SHALL PERISH." NO CARE, NO VIGILANCE, NO EFFORT TO PRESERVE AA WILL BE TOO GREAT TO HOLD US IN FULL READINESS TO TRY AND CARRY THE MESSAGE.

EACH OF US IN TURN, -- THAT IS, THE MEMBER WHO GETS THE MOST
OUT OF THE PROGRAM--SPENDS A VERY LARGE AMOUNT OF TIME ON
TWELVE STEP WORK IN THE EARLY YEARS. THAT IS THE CASE WITH MOST
MEMBERS, AND PERHAPS HE OR SHE SHOULD NOT HAVE STAYED SOBER
WITH LESS WORK.

"HOWEVER, SOONER OR LATER MOST MEMBERS ARE PRESENTED WITH OTHER OBLIGATIONS--TO FAMILY, FRIENDS AND COUNTRY. AS YOU WILL REMEMBER THE TWELFTH STEP ALSO REFERS TO PRACTICING THESE

PRINCIPLES IN ALL OUR AFFAIRS. THEREFORE, WE THINK YOUR CHOICE

OF WHETHER TO TAKE A PARTICULAR TWELVE STEP JOB IS TO BE FOUND

IN EACH MEMBER'S OWN CONSCIENCE. NO ONE ELSE CAN TELL FOR

CERTAIN WHAT YOU OUGHT TO DO AT A PARTICULAR TIME. EACH MEMBER

MUST LIVE WITH HIMSELF, UNDER SUCH DECISIONS."

"WE JUST KNOW THAT YOU ARE EXPECTED, AT SOME POINT, TO DO MORE THAN CARRY THE MESSAGE OF AA TO OTHER ALCOHOLICS. IN AA WE AIM NOT ONLY FOR SOBRIETY--WE TRY AGAIN TO BECOME CITIZENS OF THE WORLD THAT WE REJECTED, AND OF THE WORLD THAT ONCE REJECTED US. THIS IS THE ULTIMATE DEMONSTRATION TOWARD WHICH TWELFTH STEP WORK IS THE FIRST BUT NOT THE FINAL STEP."

THE CHIEF PURPOSE OF AA IS SOBRIETY. WE ALL REALIZE THAT WITHOUT SOBRIETY WE HAVE NOTHING.

HOWEVER, IT IS POSSIBLE TO EXPAND THIS SIMPLE AIM INTO A GREAT DEAL OF NONSESE, SO FAR AS THE INDIVIDUAL MEMBER IS CONCERNED.

SOMETIMES WE HEAR HIM SAY, IN EFFECT, SOBRIETY IS MY SOLE RESPONSIBILITY. AFTER ALL, I'M A PRETTY FINE CHAP, EXCEPT FOR MY DRINKING. GIVE ME SOBRIETY AND I'VE GOT IT MADE!!!

AS LONG AS A MEMBER CLINGS TO THIS COMFORTABLE ALIBI, HE OR SHE WILL MAKE SO LITTLE PROGRESS WITH HIS REAL LIFE PROBLEMS AND RESPONSIBILITIES THAT HE OR SHE STANDS IN A FAIR WAY TO GET DRUNK AGAIN. THIS IS WHY AA URGES THAT THE MEMBER "PRACTICES THESE PRINCIPLES IN ALL OUR AFFAIRS." WE ARE NOT LIVING JUST TO BE SOBER; WE ARE LIVING TO LEARN, TO SERVE, AND TO LOVE.

THE ESSENCE OF ALL GROWTH IS A WILLINGNESS TO CHANGE FOR THE BETTER AND THEN AN UNREMITTING WILLINGNESS TO SHOULDER WHAT-EVER RESPONSIBILITY THIS ENTAILS.

GRADUALLY WE BEGAN TO BE ABLE TO ACCEPT THE OTHER FELLOW'S SINS AS WELL AS HIS VIRTUES. WE COINED THE POTENT AND MEANING-FUL EXPRESSION, "LET US ALWAYS LOVE THE BEST IN OTHERS--AND NEVER FEAR THEIR WORST."

FINALLY, WE BEGAN TO SEE THAT ALL PEOPLE, INCLUDING OURSELVES, ARE TO SOME EXTENT EMOTIONALLY ILL AS WELL AS FREQUENTLY
WRONG. WHEN THIS HAPPENS, WE APPROACH TRUE, TRUE TOLERANCE
AND WE SEE WHAT REAL LOVE FOR OUR FELLOWS ACTUALLY MEANS.
WE SHOW AS MUCH TOLERANCE TO OUR FELLOWMAN AS ALCOHOLICS
ANONYMOUS SHOWS TOLERANCE FOR US.

OUR ENTIRE AA PROGRAM RESTS UPON THE PRINCIPLE OF MUTUAL TRUST. WE TRUST GOD, WE TRUST AA, AND WE TRUST EACH OTHER. THEREFORE, IF THIS TRUST IS 100% WE FIND NOTHING BUT HAPPINESS IN THE FELLOWSHIP. WHEN THIS TRUST IS BROKEN OR NON-EXISTENT IT CAN BRING NOTHING BUT UNHAPPINESS.

UNITED WE STAND. DIVIDED WE STAGGER!!!!!

THIS WE OWE TO AA'A FUTURE: TO PLACE OUR COMMON WELFARE
FIRST; TO KEEP OUR FELLOWHIP UNITED. FOR ON AA UNITY DEPEND OUR
LIVES, AND THE LIVES OF THOSE TO COME.

CHAPTER TWO

THE GROUP

TRADITIONALLY, ANY TWO OR MORE ALCOHOLICS MEETING TOGETHER FOR PURPOSES OF SOBRIETY MAY CONSIDER THEMSELVES AN AA GROUP, PROVIDED THAT, AS A GROUP THEY ARE SELF-SUPPORTING AND HAVE NO OUTSIDE AFFILIATION.

THE GROUP IS THE CENTER AND HEART OF THE AA FELLOWSHIP. IT

IS, IN MANY WAYS A UNIQUE TYPE OF GATHERING AND ONE THAT IS LIKELY

TO SEEM STRANGE TO THE NEWCOMER. THE QUESTIONS AND ANSWERS

THAT FOLLOW SUGGEST HOW THE AA MEETING FUNCTIONS AND HOW THE

NEWCOMER FITS INTO THE GROUP PICTURE.

HOW DOES A PERSON JOIN AA?

NO ONE "JOINS" AA IN THE USUAL SENSE OF THE TERM. NO APPLICIATION FOR MEMBERSHIP HAS TO BE FILLED OUT. IN FACT, MANY GROUPS DO NOT EVEN KEEP MEMBERSHIP RECORDS. THERE ARE NO INITIATION FEES, NO DUES, NO ASSESSMENTS OF ANY KIND. MOST PEOPLE BECOME ASSOCIATED WITH AA SIMPLY BY ATTENDING THE MEETINGS OF A PARTICULAR LOCAL GROUP. THEIR INTRODUCTION TO AA MAY HAVE COME ABOUT IN ONE OF SEVERAL WAYS. HAVING COME TO THE POINT IN THEIR DRINKING WHERE THEY SINCERELY WANTED TO STOP, THEY MAY HAVE BEEN IN TOUCH WITH A LOCAL GROUP VOLUNTARILY. OTHERS MAY HAVE BEEN GUIDED TO A LOCAL AA GROUP BY A FRIEND, RELATIVE, DOCTOR OR SPIRITUAL ADVISER. USUALLY, A NEWCOMER TO AA HAS AN OPPORTUNITY TO TALK TO ONE OR MORE LOYAL MEMBERS BEFORE HE OR SHE

ATTEND THEIR FIRST MEETING. THEY HAVE AN OPPORTUNITY TO LEARN HOW AA HAS HELPED THESE PEOPLE. THEY GET THE FACTS ABOUT ALCOHOLISM AND AA, WHICH HELPS THEM DETERMINE WHETHER OR NOT THEY ARE HONESTLY PREPARED TO GIVE UP ALCOHOL.

THERE ARE NO MEMBERSHIP DRIVES IN AA. IF AFTER ATTENDING SEVERAL MEETINGS, THE NEWCOMER DECIDES AA IS NOT FOR HIM, NO ONE WILL URGE HIM TO CONTINUE HIS ASSOCIATION. IF MAYBE SUGGESTED THAT HE KEEP "AN OPEN MIND" ON THE SUBJECT, BUT NO ONE IN AA WILL TRY TO MAKE UP HIS OR HER MIND FOR THEM. THE ALCOHOLIC HIS SELF IS THE ONLY ONE WHO CAN TELL WHETHER OR NOT HE NEEDS ALCOHOLICS ANONYMOUS. THEREFORE, A GROUP IS MADE UP OF MEMBERS OF ALCOHOLICS ANONYMOUS WHO HAVE A DESIRE TO STOP DRINKING, AND WHO WISH TO ASSOCIATE WITH THAT PARTICULAR GROUP.

WHAT IS AN OPEN MEETING?

AN OPEN MEETING OF AA IS A GROUP MEETING THAT ANY MEMBER OF THE COMMUNITY. ALCOHOLIC OR NON-ALCOHOLIC, MAY ATTEND. THE ONLY OBLIGATION IS THAT OF NOT DISCLOSING THE NAMES OF AA MEMBERS OUTSIDE THE MEETING.

A TYPICAL OPEN MEETING WILL BE OF THE SPEAKER TYPE, MEMBERS

HE SHE

OF AA TALKING, TELLING WHAT IT WAS LIKE, WHAT HAPPENED AND

HE SHE

WHAT IT IS LIKE TODAY. THE MEETING IS USUALLY ONE HOUR. MOST

OPEN MEETINGS CONCLUDE WITH A SOCIAL PERIOD, SERVING COFFEE,

ETC.

WHAT IS A CLOSED MEETING?

A CLOSED MEETING IS LIMITED TO ALCOHOLICS ONLY. THE PURPOSE OF A CLOSED MEETING IS TO GIVE ALCOHOLICS AN OPPORTUNITY TO DISCUSS PARTICULAR PHASES OF THEIR ALCOHOLIC PROBLEM WHICH CAN BE UNDERSTOOD BEST ONLY BY OTHER ALCOHOLICS.

THESE MEETINGS ARE USUALLY CONDUCTED WITH MINIMUM INFORMALTIY AND ALL MEMBERS ARE ENCOURAGED TO PARTICIPATE IN THE DISCUSSIONS. THE CLOSED MEETING IS OF PARTICULAR VALUE TO THE NEWCOMERS SINCE IT GIVES THEM AN OPPORTUNITY TO ASK QUESTIONS WHICH MAYBE TROUBLING THEM AND TO GET THE BENEFIT OF THE "OLDER" MEMBERS EXPERIENCE WITH THE RECOVERY PROGRAM.

I AM SURE IN YOUR MIND YOU ARE SAYING "HOW DO THINGS GET DONE IN THE AA GROUPS?"

ALL SORTS OF JOBS HAVE TO BE DONE TO KEEP AN AA GROUP GOING--OR TO START ONE. MOST OF US AGREE, AA, AS SUCH OUGHT NEVER BE
ORGANIZED; BUT WE MAY CREATE SERVICE BOARDS OR COMMITTEES
DIRECTLY RESPONSIBILE TO THOSE THEY SERVE (TRADITION9).

IT IS THROUGH THE WORK OF THE GROUP MEMBERS IN AA THAT----

- 1. ALCOHOLICS IN THE COMMUNITY LEARN THAT AA IS AVAILABLE AND HOW TO FIND IT.
- 2. CALLS FOR HELP ARE ANSWERED.
- 3. A MEETING PLACE IS PROVIDED, MADE READY, AND CLEANED UP AFTER THE MEETING.
- 4. PROGRAMS ARE ARRANGED FOR MEETINGS.
- 5. CONFERENCE APPROVED LITERATURE IS ON HAND, AND REFRESH-MENTS ARE SERVED.

- 6. THE NECESSARY MONEY IS COLLECTED AND PROPERLY SPENT.
- 7. GROUP PROBLEMS GET SOLVED.
- 8. NECESSARY CONTACT IS MADE WITH THE REST OF AA. SUCH AS OTHER GROUPS, INTER-GROUP AND GSO.

IT TAKES PEOPLE TO GET THESE JOBS DONE. IN AA WE CALL THEM
"OFFICERS". BUT OUR SECOND TRADITION REMINDS US THAT "OUR LEADERS
ARE BUT TRUSTED SERVANTS, THEY DO NOT GOVERN."

THEY ARE USUALLY CHOSEN BY THE GROUP FOR A LIMITED TERM OF SERVICE.

THE JOBS THEY DO MAY HAVE TITLES. BUT TITLES IN AA DO NOT BRING AUTHORITY OR HONOR; THEY DESCRIBE SERVICES AND RESPONSIBILITIES. THIS SERVICE IN AA IS ONE WAY OF "CARRYING THE MESSAGE."

THEY ARE FORMS OF TWELVE STEP WORK AN AA MEMBER DOES, PRIMARILY TO HELP HIMSELF RECOVER. IT IS SAID THAT LEARNING TO ACCEPT RESPONSIBILITY IN THE GROUP IS A PRIVILEGE. HANDLED PROPERLY IT CAN BE HELPFUL IN RECOVERY. MANY AA MEMBERS HAVE FOUND GROUP DUTIES AN EXCELLENT WAY TO STRENGTHEN THEIR OWN SOBRIETY.

INDIVIDUAL GROUPS HAVE MANY WAYS OF MAKING SURE THE NECESSARY SERVICES ARE PERFORMED WITH MINIMUM OF ORGANIZATION. FOR EXAMPLE, A TYPICAL GROUP MIGHT HAVE THE FOLLOWING SERVANTS OR WORKERS:

- 1. STEERING COMMITTER MEMBERS (ROTATED APPROXIMATELY EVERY YEAR, SOMETIMES SOONER).
- 2. GROUP CHAIRMAN
- 3. SECRETARY
- 4. TREASURER

- 5. GENERAL SERVICE REPRESENTIVE (GSR) (WILL DISCUSS IN DISTRICT SERVICE).
- 6. INTERGROUP REPRESENTIVE (WILL DISCUSS WITH INTER-GROUP).
 SUCH COMMITTEES AND SERVANTS VARY FROM PLACE TO PLACE.
 LARGE GROUPS MAY NEED MORE COMMITTEES ETC.

A STEERING COMMITTEE DUTIES ARE TO ANSWER QUESTIONS ABOUT WHAT A GROUP SHOULD DO AND HOW. THE STEERING COMMITTEE IS ONE WAY OF GETTING THOSE QUESTIONS HANDLED FOR THE GROUP.

AS AN EXPERIENCED CROSS SECTION OF THE GROUP MEMBERSHIP,

1T CAN HANDLE DAY TO DAY OPERATION FOR THE GROUP.

ANYWHERE FROM THREE TO FIVE MEMBERS MAYBE THE RIGHT SIZE STEERING COMMITTEE FOR A SMALL GROUP. FOR LARGER GROUPS MORE.

IN MANY GROUPS THE OFFICERS ARE AUTOMATICALLY THE STEERING COMMITTEE. SOMETIMES FORMER OFFICERS MAKE GOOD MEMBERS, DUE TO THEIR EXPERIENCE.

IN MOST GROUPS, THE CHAIRMAN IS THE CHIEF OFFICER FOR A STATED PERIOD OF TIME.

LIKE OTHER GROUP SERVANTS, HE OR SHE SHOULD HAVE BEEN SOBER
AWHILE--PROBABLY A YEAR. HE SHOULD HAVE HAD OTHER GROUP SERVICE
EXPERIENCE BEFORE TAKING THE JOB. AT LEAST THAT'S WHAT MOST
GROUPS HAVE FOUND WORKS BEST.

HE "CO-ORDINATES" GROUP ACTIVITIES, TRYING TO PREVENT CONFUSIONS AND MISUNDERSTANDING IN GROUP AFFAIRS. HE CALLS STEERING COMMITTEE MEETINGS AND PRESIDES OVER THEM. HE MAY OPEN ALL REGULAR GROUP MEETINGS, THEN TURN THEM OVER TO ANOTHER MEMBER WHO IS THE LEADER FOR THAT ONE SESSION ONLY.

OR THE LEADER CAN HANDLE THE COMPLETE MEETING.

THE CHAIRMAN HAS FINAL RESPONSIBILITY FOR THE SMOOTH FUNC-TIONING OF THE GROUP. ACTUALLY, IT DOESN'T SEEM TO MATTER WHICH GROUP OFFICER DOES WHICH JOB, AS LONG AS THEY ALL GET DONE WITHOUT CONFUSION OR CONFLICT. IT IS VERY IMPORTANT FOR EVERYBODY TO UNDERSTAND WHO IS TO DO WHAT.

THE CHAIRMAN IS THE GROUP MEMBER GENERALLY RESPONSIBLE FOR MAINTAINING GOOD RELATIONS BETWEEN THE GROUP AND ITS NEIGHBOR-HOOD COMMUNITY, STARTING WITH THE LANDLORD.

FOR EXAMPLE; IF THE GROUP MEETS ON CHURCH PROPERTY, WHAT THE PASTOR, THE JANITOR, AND THE CHURCH MEMBERS THINK OF AA DEPENDS MOSTLY ON THE BEHAVIOR OF THE GROUPS MEMBERS. IF AA MEMBERS SEEM TO BE NICE FOLKS, OUR WORK IS RESPECTED, AND SICK ALCOHOLICS ARE ENCOURAGED TO CONTACT US. IF WE ARE FOUND TROUBLESOME, THE WORD GETS PASSED AROUND ABOUT US AND DOES NOT ATTRACT ALCOHOLICS TO US.

THE SAME GOES, FOR LOCAL DOCTORS, POLICE, SOCIAL WORKERS AND OTHERS WHO ENCOUNTER SICK ALCOHOLICS.

USUALLY, THE BETTER INFORMED A CHAIRMAN IS ABOUT ALL AA,
THE BETTER HE OR SHE FUNCTIONS AS CHAIRMAN. MOST CHAIRMAN
AGREE IT'S A GOOD IDEA NOT TO EXPECT LOTS OF PRAISE. THE KEY
TO KEEPING A GROUP IN GOOD STEAD IS TO USE THE TRADITIONS.

CHAPTER TWO-B

THE GROUP

SOME GROUPS HAVE NO CHAIRMAN, BECAUSE THE SECRETARY SERVES
AS THE GROUP OFFICER. THESE ARE SOME OF THE RESPONSIBILITIES OF
A SECRETARY:

- 1. TAKE OVER WHEN THE CHAIRMAN IS NOT THERE.
- 2. SEES TO CONFERENCE APPROVED LTERATURE, ALL BOOKS OF AA ARE ON DISPLAY AT MEETINGS.
- 3. MAKES SPECIAL ANNOUNCEMENTS
- 4. IF THE GROUP KEEPS MEMBERSHIP, IT IS HIS OR HER JOB TO KEEP THE RECORDS.
- 5. ACCEPTS AND ASSIGNS TWELVE STEP CALLS IF NECESSARY.
- 6. CORRESPONDS WITH OTHER GROUPS.
- 7. ATTENDS TO THE POST OFFICE BOX.
- 8. KEEPS THE ANNIVERSARY FILE.
- 9. HELPS THE TREASURER AND CO-SIGNS CHECKS.
- 10. TAKES CARE OF BULLETINS AND ANNOUNCEMENTS
- 11. HELPS GSR, DOING WHAT IS NECESSARY
- 12. KEEPS INTER-GROUP AND GSO INFORMED AS TO MEETING PLACE, NEW OFFICERS, AND ETC.

LIKE ANYOTHER GROUP OFFICER. THE SECRETARY HAS THE RESPON-SIBILITES TO SEE THAT NEWCOMERS GET HELP.

AA GROUPS ARE SELF-SUPPORTING, ACCEPTING MONEY ONLY FROM MEMBERS. (TRADITION 7) PASSING THE HAT IS USUALLY ALL A GROUP HAS TO DO, TO MEET ITS NEEDS. THERE IS NO FORMAL OBLIGATION FOR

ANY MEMBER TO CONTRIBUTE BUT MOST DO CONTRIBUTE A DOLLAR.

AA SAYS, "DON'T GIVE TILL IT HURTS, BUT TILL IT FEELS GOOD."

GROUP FUNDS GO FOR SUCH SERVICES AS:

- 1. RENT FOR MEETING PLACES
- 2. REFRESHMENTS
- 3. MISCELLANEOUS EXPENSE SUCH AS: LIGHTS, COFFEE CUPS, SPOONS, ASHTRAYS, POSTAGE, TELEPHONE, AND ETC.
- 4. ALL AA CONFERENCE LITERATURE. HARD COVER WE SELL, PAM-PHLETS ARE USUALLY FREE.
- 5. MONTHLY PAYMENT TO INTER-GROUP.
- 6. MONTHLY PAYMENT TO GSO.
- 7. ANNUAL PAYMENT TO AREA GS COMMITTEE FOR DELEGATE EXPENSES.
- 8. QUESTION ANY EXPENSE NOT ACCORDING TO TRADITIONS OF AA.

THE TREASURERUSUALLY KEEPS GOOD SIMPLE RECORDS AND KEEPS HIS GROUP INFORMED ABOUT HOW MUCH IS TAKEN IN AND HOW MUCH IS SPENT. HE GIVES MONTHLY REPORTS AND QUARTERLY FINANCIAL STATEMENTS.

PROBLEMS CAN BE AVOIDED BY KEEPING THE GROUP FUNDS IN A SEPARATE GROUP BANK ACCOUNT WHICH REQUIRES TWO SIGNITURES ON EACH CHECK. THERE ARE OTHER WAYS OF DOING THIS JOB AND ANY OTHER AA TASK BUT THE METHODS SUGGESTED HERE HAVE PROVED TO ELIMINATE TROUBLES LATER.

IT IS A GOOD IDEA TO BUDGET ALL EXPENSES IN ADVANCE, SETTING ASIDE SUMS FROM EACH COLLECTION IN ORDER TO MEET MONTHLY PLEDGES AND BILLS.

AA EXPERIENCES CLEARLY SHOW THAT IT IS NOT A GOOD IDEA FOR A

GROUP TO ACCUMULATE LARGE SUMS IN EXCESS OF WHAT IS NEEDED.

JUST A PURDENT RESERVE.

GROUP TREASURIES ARE USED FOR ALL GROUP EXPENSES, BUT NOT FOR MEMBER'S EXPENSES IN TWELVE STEP WORK. THIS IS A CARDINAL PRINCIPLE.

MOST GROUPS SEND GSO, NEW YORK \$3.65 PER MEMBER ANNUALLY FOR THEIR PART IN PAYING EXPENSES FOR WORLD SERVICE HANDLED IN OUR GSO OFFICE. DUTIES OF GSO TO BE EXPLAINED AT A LATER DATE.

A MONTHLY CHECK SHOULD BE MAILED EACH MONTH FOR PART PAY-MENT. GSO HAS MONTHLY EXPENSES JUST LIKE OUR GROUP AND IF WE DO NOT DO OUR PART IN A SYSTEMATIC MANNER IT EFFECTS THEIR EFFECTIVENESS.

EACH GROUP HAS A RESPONSIBILITY TO HELP PAY EXPENSES FOR INTER-GROUP OFFICE IN THEIR COUNTY OR AREA THEY SERVE. EACH GROUP SETS THEIR MONTHLY PAYMENT ONCE A YEAR AND THE GROUP EXPECTS THE TREASURER TO MAIL A CHECK MONTHLY FOR THAT AMOUNT TO THE INTER-GROUP. DUTIES OF INTER-GROUP TO BE EXPLAINED AT A LATER DATE.

THE PROGRAM CHIRMAN IS USUALLY APPOINTED FOR ONE MONTH
AND IT IS HIS DUTY TO ARRANGE FOR MEETINGS. IF THERE IS AN INTERCHANGE AGREEMENT BETWEEN GROUPS, IT IS HIS DUTY TO ARRANGE FOR
THE EXCHANGE OF SPEAKERS. HE ARRANGES THE CHAIRS, ASHTRAYS
AND IN GENERAL TAKES CARE OF THE MEETING BEFORE AND AFTER.

THE REFRESHMENT COMMITTEE FURNISHES THE COFFEE, CAKE, COOKIES OR EATS, AND CLEANS UP THE REFRESHMENT AREA AFTER

THE MEETING.

GROUP WORKERS OR SERVANTS ARE CHOOSEN FOR A LIMITED TERM
OF SERVICE, ONE MONTH, SIX MONTHS, OR A YEAR, IT VARIES. IT IS
WISE TO USE A ROTATI NG SYSTEM, WHERE NO ONE MEMBER SERVES TOO
LONG. EACH MEMBER SHOULD BE ASKED TO SERVE. THE MORE YOU
HAVE YOUR MEMBERSHIP DOING THE BETTER THE GROUP. MORE AND
MORE GROUP SERVANTS HAVE FOUND THAT KNOWLEDGE ABOUT THE THREE
AA LEGACIES HELP THEM DO A BETTER JOB. THE MORE WE ELIMINATE
FAVORITISM AND KEEP NOMINATING OUR SERVANTS ON A NON POLITICKING
PROCEDURE WE SELECT THE RIGHT MEMBERS FOR THE RIGHT OFFICE.
WE PICK SERVANTS IN AA FOR THEIR ABILITY NOT THEIR PERSONALITY.

EACH GROUP IS AUTONOMOUS AS TO THE TYPE, LENGTH, LOCATION, REFRESHMENTS, GROUP DONATIONS, ETC., AS LONG AS ALL MEMBERS OF A GROUP ARE ALCOHOLICS, AND THEY ARE FULLY SELF-SUPPORTING. A GROUP'S PRIMARY PURPOSE IS TO HELP ALCOHOLICS RECOVER THROUGH THE AA PROGRAM AND AS A GROUP THEY HAVE NO OUTSIDE AFFILIATION. AS A GROUP THEY HAVE NO OPINION ON OUTSIDE ISSUES AND AS A GROUP, THEIR PUBLIC RELATIONS POLICY IS BASED ON ATTRACTION RATHER THAN PROMOTION, AND THEY NEED ALWA YS MAINTAIN THEIR PERSONAL ANONYMITY AT THE LEVEL OF PRESS, RADIO, TELEVISION AND FILMS.

CHAPTER THREE

INTER-GROUP OFFICES

AN INTER-GROUP IS AN AA SERVICE OFFICE THAT INVOLVES A PARTNERSHIP AMONG GROUPS IN A GIVEN DISTRICT. IT IS ESTABLISHED
TO CARRY OUT CERTAIN FUNCTIONS COMMON TO ALL GROUPS--FUNCTIONS
WHICH ARE BEST HANDLED BY A CENTRALIZED OFFICE--AND IT IS
USUALLY MAINTAINED, SUPERVISED, AND SUPPORTED BY THESE GROUPS
IN THEIR GENERAL INTEREST. IT EXISTS TO AID GROUPS IN THEIR COMMON
PURPOSE OF CARRYING THE AA MESSAGE TO THE ALCOHOLIC WHO STILL
SUFFERS.

THE AA EXPERIENCE HAS CLEARLY DEMONSTRATED THAT THE INTERGROUP OFFICES ARE ESSENTIAL, PARTICULARLY IN POPULUS AREAS.

THERE ARE OVER 180 INTER-GROUP OFFICES NOW FUNCTIONING THROUGHOUT THE WORLD, PERFORMING VITAL AND INDISPENSABLE AA SERVICES.

NEEDLESS TO SAY, THESE CONSTITUTE A NETWORK OF SERVICE OUTLETS
AND AA CONTRACTS FOR WHICH WE SHOULD BE VERY GRATEFUL.

SOMETIMES, HOWEVER, INTER-GROUP OFFICE VENTURES HAVE
BOGGED DOWN IN DISPUTES OVER MONEY, AUTHORITY AND LIKE MATTERSTHUS BECOMING LESS EFFECTIVE IN CARRYING THE AA MESSAGE. IT'S NOT
ALWAYS CLEAR WHY THESE TROUBLES HAVE COME UP, BUT OFTEN IT'S
BEEN BECAUSE THE PROPER FUNCTIONS OF AN INTER-GROUP OFFICE
WERE NOT CLEARLY EXPLAINED OR UNDERSTOOD, OR THERE WAS
SOME DISREGARD OF THE PRINCIPLES OF AA'S TWELVE TRADITIONS.

SO THE FOLLOWING SUGGESTIONS ARE WISE TO REMEMBER AS SOME OF THE BASIC SERVICES AN INTER-GROUP MIGHT OFFER.

- (1) AA INQUIRIES -- PROVIDES AA LISTINGS IN LOCAL PHONE DIRECTORY, THE OFFICE MAY RECEIVE INQUIRIES FROM THOSE SEEKING HELF AND SEND THEM TO THE APPROPRIATE AA GROUP OR ARRANGE ALSO TO HAVE SOMEONE MAKE A TWELVE STEP CALL ON THE NEW MEMBER.
- (2) OFFICE FACILITIES -- CAN MAINTAIN A CONVENIENTLY LOCATED OFFICE IN WHICH PAID WORKERS AND OR VOLUNTEERS ARE AVAILABLE TO HELP WITH ANY ALCOHOLIC PROBLEM.
- (3) INFORMATION EXCHANGE--THE OFFICE IS USED AS A CLEARING HOUSE FOR ALL INFORMATION AMONG ALL THE GROUPS IN THE AREA. THEY ALSO PRODUCE A MEETING DIRECTORY OF THE AREA CALLED "WHEN AND WHERE", WHICH IS PRINTED QUARTERLY.
- (4) LOCAL PUBLIC RELATIONS -- IDEAL CONTACT FOR THOSE IN THE COMMUNITY SEEKING INFORMATION ABOUT ALCOHOLISM AND AA. SUCH
- AS: (A) ARRANGING AA SPEAKERS FOR NON-ALCOHOLIC GROUPS.
 - (B) MAINTAINING A POST OFFICE BOX TO PROTECT ANONYMITY
 - (C) ASSISTING THE PRESS AND PUBLIC MEDIA IN ALL TYPES OF
 - (D) COOPERATION WITH OTHER COMMUNITY AGENCIES WHICH DEAL
 - (E) ANY BUSINESS OF AA WHICH INVOLVES THE TOTAL GROUPS IN THE AREA.
- (5) HOSPITALIZATION -- ARRANGING FOR THE ALCOHOLIC AND HIS FAMILY TO GET INFORMATION ON WHICH HOSPITAL WILL ACCEPT ALCOHOLICS.
- (6) AA IN INSTITUTIONS--MAINTAIN CONTACT WITH LOCAL GROUPS IN PRISONS AND OFFERING SERVICES TO THEM.

- (7) LOCAL AA EVENTS--DISTRIBUTE THE INFORMATION ON AA EVENTS.
- (8) AA BULLETIN OR NEWSLETTER -- INTER-GROUP PUBLISHES A NEWSLETTER MONTHLY. COPIES ARE AVAILABLE ON LITERATURE TABLE.

EACH GROUP HAS AN INTER-GROUP REPRESENTATIVE AND THIS COM-MITTEE MEETS ONCE A MONTH. IT IS THE DUTY OF THIS INTER-GROUP REPRESENTATIVE TO REPORT TO HIS OR HER GROUP THE ACTIVITIES OF THE INTER-GROUP OR THE IMPORTANT HAPPENINGS.

FROM THE GROUP REPRESENTATIVES THEY ELECT A STEERING COMMITTE WHICH HANDLES THE ADMINISTRATIVE ACTIVITIES OF THE OFFICE. THEY ALSO DEVELOP GENERAL POLICIES AND PLANS. THEN THEY PRESENT THEM TO THE GROUP REPRESENTATIVES. IT IS EXTREMELY IMPORTANT TO KEEP A TWO WAY FLOW OF INFORMATION GOING BETWEEN THE INTERGROUP OFFICE AND THE GROUPS.

HERE ARE SOME OF THE WAYS INTER-GROUP OFFICES ARE FINANCED:

- (1) THE PLEDGE SYSTEM: EACH GROUP IN THE AREA CONTRIBUTES A FIXED AMOUNT, PAID MONTHLY. THIS INSURES REGULAR INCOME.
- (2) SALE OF LITERATURE: THE INTER-GROUP BUYS AA CONFERENCE APPROVED LITERATURE IN LARGE QUANTITIES AND SELLS AT REGULAR PRICES TO ITS GROUPS.
- (3) SPECIAL GROUP COLLECTIONS: EACH WEEK SOMEWHERE IN THE AREA A GROUP IS HAVING AN "INTER-GROUP BENEFIT MEETING". ALL COLLECTION FROM THE MEETING IS GIVEN TO THE INTER-GROUP FOR OPERATION.

- (4) SPECIAL CONTRIBUTIONS: SOME INTER-GROUPS HAVE WHAT THEY CALL THE \$1.00 CLUB. AN AA MEMBER CONTRIBUTES \$1.00 PER MONTH TO INTER-GROUP OPERATIONS.
- (5) SPECIAL EVENTS: YEARLY BANQUET, AND SIMILAR EVENTS, USING "PROFITS" FOR SUPPORT OF THE OFFICE.

THE INTER-GROUP DOES NOT COME BETWEEN GENERAL SERVICE OFFICE AND THE GROUP. THESE TWO OFFICES DO NOT SUBSTITUTE FOR EACH OTHER. THE INTER-GROUP TAKES CARE OF LOCAL AFFAIRS, AND THE GSO TAKES CARE OF AA WORLD SERVICE.

URE OF THE FELLOWSHIP" ON PAGE # GIVES YOU THE CHART WE ARE

GOING TO USE IN EXPLAINING THIS STRUCTURE.

THE CONFERENCE PLAN IS A METHOD BY WHICH AA'S COLLECTIVE GROUP CONSCIENCE CAN SPEAK FORCEFULLY AND PUT ITS DESIRES FOR WORLD WIDE SERVICES INTO EFFECT. IT IS THE STRUCTURE THAT TAKES THE PLACE OF GOVERNMENT IN AA. IT INSURES THAT THE FULL VOICE OF AA WILL BE HEARD WHETHER IT REPRESENTS THE GREAT MAJORITY OR A MINORITY. THE CONFERENCE PLAN WAS ESTABLISHED AS A GUARDIAN OF OUR WORLD-WIDE SERVICES SO THEY CAN CONTINUE TO FUNCTION UNDER ALL CONDITIONS.

GROUP SERVICE REPRESENTATIVE (GSR)--THE CHART SHOWS THAT
THE BEGINNING OF WORLD WIDE SERVICE STARTS WITH THE GROUP,
YOUR GROUP. SO WITH THIS IN MIND THE GROUP HAS TO HAVE SOMEONE
TO REPRESENT THEM. THIS SERVANT IS CALLED "THE GSR"-- GENERAL
SERVICE REPRESENTATIVE. THE GSR HAS THE JOB OF LINKING HIS OR
HER GROUP WITH AA AS A WHOLE. IT IS HE OR SHE WHO REPRESENTS
THE VOICE OF THE GROUP CONSCIENCE REPORTING THE GROUP'S

WISHES TO THE COMMITTEE MEMBERS AND TO THE DELEGATE, SO
THAT IT WILL BE PASSED ON TO THE CONFERENCE AND TO THE MOVEMENT.
THE DUTIES OF COMMITTEE MEMBERS AND DELEGATES WILL BE
DISCUSSED LATER IN THEIR PART OF THE CHART.

FOR THIS, THE GSR NEEDS THE CONFIDENCE OF HIS GROUP. HE ALSO NEEDS A GOOD EAR FOR LISTENING. WE ALL REALIZE WHATEVER "AUTHORITY" THERE IS IN AA RESIDES IN THE GROUP CONSCIENCE. BECAUSE OF THIS, A GSR CAN DETERMINE EXACTLY WHAT A GROUP NEEDS, WHAT A GROUP THINKS ABOUT IN A SITUATION, AND THEN PASS THIS INFORMATION ALONG TO WHERE IT WILL BE MOST USEFUL IN POLICY MAKING.

THIS IS A TWO WAY STREET, ALLOWING THE GSR TO BRING BACK
TO HIS GROUP THE PROBLEMS AND REMEDIES THAT AFFECT UNITY,
HEALTH AND GROWTH. ONLY TO THE EXTENT THAT A GSR KEEPS
HIS GROUP INFORMED AND EXPRESSES THE GROUP CONSCIENCE CAN
THE CONFERENCE FEEL IT IS ACTING FOR AA AS A WHOLE. THIS
BECOMES MORE EVIDENT--WHETHER A GSR SPEAKS FOR A GROUP OF
TWO OR THREE OR A GROUP WITH 250 MEMBERS.

EXPERIENCE SHOWS THE MOST SUCCESSFUL GSR IS AN AA MAN OR
WOMAN WHO HAS BEEN ACTIVE AS A GROUP OFFICER. 'FROM THIS,
HE HAS ALREADY LEARNED THAT AA OFFERS GROWTH THROUGH SERVICE,
AND HE OR SHE BECOMES AWARE OF THE MEANING OF OUR TRADITIONS
TO THE MOVEMENT'S FUTURE.

USUALLY, THE PROSPECTIVE GSR HAS HAD TWO YEARS OF CONTINUOUS SOBRIETY IN AA, AND HAS TIME AVAILABLE FOR DISTRICT AND ASSEMBLEY MEETINGS. THE GROUP SHOULD CONSIDER WHETHER A CANDIDATE HAS THE CAPABILITIES AND THE TIME FOR POSSIBLE FUTURE ASSIGNMENTS IN SERVICE.

IN ORDER THAT EACH GROUP MAY MAKE A WISE SELECTION, IT IS
WELL FOR IT TO KNOW WHAT ITS GSR WILL ACTUALLY BE DOING.
ONE OF A GSR'S FUNCTIONS IS TO HELP ELECT COMMITTEE MEMBERS
AND DELEGATES. THAT IS ONE VERY IMPORTANT PART OF THE JOB, BUT
MUCH MORE IS EXPECTED.

- (1) THE GSR IS THE MAIL CONTACT WITH GSO AND IS LISTED IN THE WORLD DIRECTORY AS THE GROUP CONTACT IN YOUR COMMUNITY.

 THE GSR RECEIVES FROM GSO BOX 459, PUBLICATIONS WHICH KEEP THE GROUP ABREAST OF AA ACTIVITIES ALL OVER THE WORLD. THE GSR ALSO IS THE MAIL CONTACT WITH HIS DISTRICT AND AREA COMMITTEES.
- (2) BEYOND THIS THE GSR KEEPS GSO SUPPLIED WITH GROUP INFOR-MATION. CHANGES OF OFFICERS, MEETINGS AND ETC. ALSO HE KEEPS ANNUAL GROUP INFORMATION CARDS, ESSENTIAL FOR THE WORLD DIRECTORY AND FOR GSO MAILINGS.
- (3) GSR'S KNOW WHAT MATERIAL IS AVAILABLE FROM GSO--GUIDE-LINES, BULLETINS, FILM STRIPS, TAPES, KITS AND ETC.
- (4) GSO KEEPS THE GSR ADVISED OF NEW LITERATURE. IT IS HIS OR HER RESPONSIBILITY TO MAKE SURE THE GROUP IS INFORMED OF THE AVAILABLITY OF CONFERENCE APPROVED PAMPHLETS AND BOOKS.

- (5) THE GSR FAMILIARIZES HIMSELF WITH CONFERENCE APPROVED LITERATURE.
 - (6) THE GSR SERVES ON THE STEERING COMMITTEE OF THE GROUP.
- (7) THE GSR CHECKS TO BE SURE THAT THE GROUP CONTRIBUTES TO INTER-GROUP AND GSO ON A MONTHLY BASIS AND SEES ALSO OTHER OBLIGATIONS OF THE GROUP ARE MET.
- (8) THE GSR PARTICIPATES IN DISTRICT AND AREA SERVICE MEETINGS AND REPORTS BACK TO THE GROUP. MOST DISTRICTS MEET MONTHLY.
- (9) THE GSR KNOWS THE GROUP HANDBOOK AND HELPS EXPLAIN GSO LERVICES TO HIS OR HER GROUP AND NEW GROUPS IN THE DISTRICT.

THE GSR SERVES FOR TWO YEARS. HE IS ELECTED IN THE FALL
OF AN ODD YEAR, THE SAME AS THE PANEL IN THIS AREA. THE GSR'S
TERM RUNS CONCURRENTLY WITH THOSE OF THE AREA COMMITTEE
MEMBERS AND THE DELEGATE. THE DATE OF THE ELECTION OF A GSR
IS IMPORTANT FOR TWO REASONS: 1. BECAUSE IT SHOULD BE BEFORE
THE ASSEMBLY CALLED FOR THE ELECTION OF THE AREA DELEGATE.
2. BECAUSE THE DEADLINE FOR LISTING THE NAMES OF DELEGATES
AND GSR'S IN THE WORLD DIRECTORY IS DECEMBER FIRST. SEPTEMBER
SEEMS TO BE THE BEST MONTH. THE NEW GSR AND DELEGATE TAKE

OFFICE THE FOLLOWING JANUARY FIRST, REGARDLESS OF THE DATE

OF THE ELECTION.

THE MISTAKE IS SOMETIMES MADE IN ELECTING A GSR. THE MEMBERS

OF THE GROUP FAIL TO REALIZE THE IMPORTANCE OF THIS SERVANT.

WHEN YOUR GROUP ELECTS THE GSR, BE SURE THE OFFICE IS FILLED BY A MEMBER WHOWILL DO THE BEST JOB FOR THE GROUP. NOT ONE WHO YOU MIGHT LIKE PERSONALLY. WE ELECT SERVANTS IN AA TO SERVE, NOT TO HELP THEM BECOME BETTER AA MEMBERS OR TO HELP THEM STAY SOBER. SO MANY TIMES THIS HAPPENS AND IN THE END THE GROUP IS THE ONE WHO SUFFERS. SO GIVE CAREFUL CONSIDERATION TO WHO YOU PICK FOR YOUR GROUP GSR. THEY MIGHT END UP AS YOUR COMMITTEEMAN OR DELEGATE REPRESENTING YOU WORLDWIDE.

CHAPTER FIVE

DISTRICT COMMITTEE MEMBERS

SERVED AS A GSR, AND WHOM THE OTHER GSR'S DECIDE THEY WANT TO MAKE RESPONSIBLE FOR THEIR DISTRICT. A DISTRICT IS A GEOGRAPHICAL DIVISION WITHIN AN AREA. ON THE MAP OF THE SOUTH FLORIDA ASSEMBLEY AREA YOU WILL FIND THE BROWARD COUNTY DISTRICT. THIS MAKES COMMUNICATION EASIER BETWEEN THE GROUP AND THE AREA COMMITTEE. A DISTRICT USUALLY INCLUDES MANY GROUPS. IT COULD BE A VERY SMALL SECTION OR IT COULD BE A VERY LARGE SECTION.

THE COMMITTEE MEMBER IS RESPONSIBLE FOR GENERAL SERVICE AFFAIRS IN HIS DISTRICT. THE WORK TAKES HIM IN BOTH DIRECTIONS, TOWARD THE GROUP AND ITS GSR AND TOWARD THE COMMITTEE WITH ITS BROADER GENERAL SERVICE ACTIVITIES.

THE COMMITTEE MEMBER IS RESPONSIBLE TO DIGEST THE MATERIAL GSO SENDS HIM WHICH INCLUDES BOX 459, FINAL CONFERENCE REPORTS, THE WORLD DIRECTORY, QUARTERLY REPORTS OF THE TRUSTEES AND CORRESPONDENCE FROM THE CONFERENCE SECRETARY, AND HE KEEPS HIS GSR'S AND THE GROUPS IN HIS DISTRICT INFORMED ON WORLD WIDE AA.

IT IS ALSO HIS JOB TO HELP THE DELEGATE REPORT TO THE AREA

raum -

AND HIS DISTRICT, USING THE DELEGATE'S WRITTEN REPORT AND THE MATERIAL FROM THE CONFERENCE DIGEST AND LATER THE FINAL CONFERENCE REPORT.

AS AA GROWS THE DISTRICT REMAINS THE SAME, BUT WE ADD COMMITTEE MEMBERS. ONE COMMITTEE MEMBER SERVES EIGHT GROUPS. SOME AREAS HAVE ALTERNATE COMMITTEE MEMBERS JUST IN CASE THE NUMBER ONE BOY RESIGNS OR SOMETHING ELSE HAPPENS. THE COMMITTEE MEMBERS ARE ELECTED AT THE SAME TIME AS THE GSR'S.

THE DISTRICT COMMITTEE MEMBER THAT IS ELECTED TO BE OUR SERVANT SHOULD HAVE TWO YEARS AS A GSR AND FIVE YEARS OF SOBRIETY, INTEREST AND TIME TO ATTEND MANY DIFFERENT MEETINGS AND SOME ABILITY TO EXPRESS THE THOUGHTS OF OTHERS. ALSO ENOUGH TIME AND MONEY TO ATTEND ALL STATE AND DISTRICT MEETINGS. WE WANT ACTIVE, HARDWORKING, RESPONSIBLE AA'S WHO ARE DEDICATED TO AA SERVICE.

AS ALREADY STATED, THE ELECTION OF NEW COMMITTEE MEMBERS
FOR THE DISTRICT IS SET UP BY THE LOCAL GENERAL SERVICE
MEETING OF THE DISTRICT. IN SOME DISTRICTS, ONLY IMMEDIATE
PAST AND ALL NEW GSRS ARE ELIGIBLE TO RUN AND VOTE. IN OTHER
DISTRICTS ONLY NEWLY ELECTED GSRS ARE ELIGIBLE TO RUN AND
VOTE, AND THEN IN OTHER DISTRICTS JUST THE OUTGOING GSRS ARE
ELIGIBLE TO RUN, BUT NEW AND OLD GSRS ARE ALLOWED TO VOTE.

CHAPTER SIX

THE AREA COMMITTEE

THE AREA COMMITTEE--PERHAPS MORE THAN ANY OTHER GROUP
OF PEOPLE IN AA--IS RESPONSIBLE FOR THE HEALTH OF THE CONFERENCE STRUCTURE AND BY THE SAME TOKEN, FOR GROWTH AND
HARMONY IN OUR BELOVED FELLOWSHIP.

THE AREA FOR WHICH THE COMMITTEE IS RESPONSIBLE IS SOUTH
FLORIDA. THE AREA IS SHOWN ON THE DISTRICT MAP. THUS, THE
AREA COMMITTEE IS IN A FORTUNATE MIDDLE POSITION. THROUGH
ITS ELECTED DELEGATE, IT LEARNS FIRST HAND WHAT IS HAPPENING
IN AA WORLD SERVICE. THROUGH THE MEMBERS OF THE COMMITTEE,
IT IS CLOSE TO DISTRICT AND LOCAL SCENES. IF GSRS ARE LAX, IF
THERE IS A LACK OF HARMONY IN THE DISTRICT, THE COMMITTEE
MEMBER SOON KNOWS IT. HE CAN THEN TURN TO HIS WHOLE COMMITTEE
FOR HELP IN RESTORING PEACE OR GENERATING MORE ACTIVITY
AMONG THE GROUPS IN HIS DISTRICT. THE MIDDLE POSITION IS
INDEED A VITAL ONE.

AN ACTIVE COMMITTEE IS AWARE OF ALL KINDS OF SERVICE PROBLEMS
AND IS ALERT TO SITUATIONS WHICH HAPPEN WITH SOME FREQUENCY
THROUGHOUT THE FELLOWSHIP SUCH AS:

- (1) GROUP MEETINGS THAT ATTRACT
- (2) ACTIVE INSTITUTIONAL WORK

- (3) USEFUL PUBLIC INFORMATION
- (4) NEW GROUPS AND LONERS

THIS IS BUT A SAMPLING OF THE PROBLEMS WITH WHICH AN AREA COMMITTEE MAY FIND ITSELF INVOLVED. A PARTIAL LIST HAS BEEN GIVEN HERE TO POINT UP THE KIND OF ACTIVITY AND THE KIND OF ACTIVE AAS THE COMMITTEE NEEDS TO ACCOMPLISH ITS PURPOSE. IN OTHER WORDS, THERE IS MUCH MORE TO A COMMITTEES WORK THAN THE ELECTION OF OFFICERS AND A DELEGATE TO THE GENERAL SERVICE CONFERENCE MEETING IN NEW YORK.

COMMITTEE OFFICERS MUST HAVE LEADERSHIP, ENTHUSIASM AND KNOW-HOW PLUS THE ABILITY TO ORGANIZE AND GIVE THE COMMITTEE DIRECTION AND INCENTIVE.

THE CHAIRMAN OF THIS COMMITTEE SHOULD HAVE AT LEAST FIVE YEARS CONTINUOUS SOBRIETY, PLUS EXPERIENCE IN GROUP, INTERGROUP, AND INSTITUTIONAL AFFAIRS, SOUND UNDERSTANDING OF THE STEPS, TRADITIONS AND SERVICE, AND THE ABILITY TO PUT RECOVERY, UNITY AND SERVICE TO WORK IN HIS AREA. HE HAS TO HAVE THE ABILITY TO ACT AS A SERVANT, RATHER THAN A DICTATOR. HIS LEADERSHIP TALENT SHOULD HELP HIM INSTILL IN OTHERS A HIGH INTEREST IN CONFERENCE SERVICE, AND CERTAINLY HE OR SHE SHOULD BE ABLE TO CONDUCT A MEETING IN AN ORDERLY AND IMPARTIAL MANNER.

THE CHAIRMAN SHOULD HAVE THE ABILITY TO COMMUNICATE.

HE IS TOLERANT OF THOSE WHO CANNOT SEEM TO SEE BEYOND THEIR

GROUP HORIZON. HE IS KNOWLEDGEABLE ABOUT AA HISTORY, HE CAN RELATE AT GROUP LEVEL HISTORY AND SERVICE, BOTH LOCAL AND WORLD.

ABOVE ALL HE IS A LIVING EXAMPLE OF AA. THROUGH WATCHING HIM MEMBERS OF AA REALIZE PERHAPS FOR THE FIRST TIME THAT SERVICE TO OTHERS IS PART OF OUR PERSONAL RECOVERY.

THE SECRETARY TO THE AREA COMMITTEE ADDS GREAT VITALITY
AND DRIVE TO AN AREA COMMITTEE. EVEN THE BEST CHAIRMAN CAN
BE GREATLY HANDICAPPED BY AN INEFFICIENT SECRETARY, AND
MUCH MORE EFFECTIVE WITH A COMPETENT ONE. A SECRETARY
SHOULD HAVE:

- (1) SOBRIETY AND BUSINESS EXPERIENCE
 - (A) SERVICE IN GROUP, SUCH AS TAKING MINUTES AT MEETINGS, MAILING AND MAKING MINUTES AS TO THE ESSENCES OF WHAT HAS BEEN SAID
 - (B) AT LEAST TWO YEARS SOBRIETY
 - (C) ABLE TO TYPE
 - (D) BULLETINS
 - (E) TIME, INTEREST AND ENERGY--THE JOB IS DEMANDING
- (F) ACTS AS LIAISON BETWEEN COMMITTEE MEMBERS

 THE SECRETARY IS SO IMPORTANT THAT IT IS SAFE TO SAY "HE OR

 SHE IS THE HEART OF THE COMMITTEE".

ALL OFFICERS SHOULD HAVE A REASONABLE PERIOD OF SOBRIETY
AND HAVE LOTS OF THE QUALITIES ALREADY MENTIONED IN THE CHAIRMAN'S QUALIFICATIONS.

EACH QUARTER OF THE YEAR BY INVITATION OF THE DISTRICT,
MEETINGS ARE CALLED FOR THE GSRS AND THE AREA COMMITTEE.
THIS TYPE OF MEETING IS CALLED "AN ASSEMBLY" OR "QUARTERLY
MEETING." THIS ASSEMBLY IS THE MAINSPRING OF THE CONFERENCE
STRUCTURE. IT IS THE DEMOCRATIC VOICE OF THE MOVEMENT

EXPRESSING ITSELF. ASSEMBLIES ARE THE RESPONSIBILITY OF THE AREA COMMITTEE, AND THEY ARE CONDUCTED BY THE CHAIRMAN. AN ELECTION ASSEMBLY IS HELD AT LEAST ONCE EVERY TWO YEARS TO ELECT A DELEGATE. THE ELECTION ASSEMBLY IS USUALLY SCHEDULED IN THE FALL OF THE YEAR, PRIOR TO NOVEMBER FIRST. THE NEW OFFICERS TAKE OFFICE JANUARY FIRST.

IN THE QUARTERLY MEETINGS, WORK SHOPS ARE SET UP ON DIF-FERENT IMPORTANT ITEMS AND ARE DISCUSSED. AFTER THESE MEETINGS A GENERAL SERVICE SESSION IS CALLED AND THE CHAIRMAN OF THE WORKSHOP GIVES A REPORT ON ITS FINDINGS.

USUALLY, THE GENERAL SERVICE ASSEMBLY STARTS ITS WORK-SHOP ON SATURDAY AFTERNOON. ON SATRUDAY EVENING THERE IS USUALLY A BANQUET AND AFTER DINNER AN AA MEETING.

ON SUNDAY MORNING THE CHAIRMAN CALLS THE ASSEMBLY TO

ORDER AND THE AGENDA PREPARED BY THE CHAIRMAN IS FOLLOWED.

THIS AGENDA INCLUDES LAST ASSEMBLY MINUTES, TREASURY REPORT,

ALL AREA COMMITTEE REPORTS, COMMITTEE REPORTS ON ALL MATTERS,

OLD BUSINESS AND NEW BUSINESS.

THERE IS ALSO DISCUSSION ON GSO ACTIVITIES INCLUDING GRAPEVINE, LITERATURE. AND SPECIAL ITEMS OF INTEREST.

ON MATTERS WHICH CALL FOR A VOTE, ALL COMMITTEE MEMBERS
AND OFFICERS, ALL GSRS, AND THE DELEGATES HAVE ONE VOTE EACH
IN AN ASSEMBLY. ALTERNATES NORMALLY VOTE ONLY IF THE REGULAR
COMMITTEE MEMBER OR GSR IS NOT PRESENT. PROXY CAN BE USED,

BUT IT IS NOT A COMMON PRACTICE. EACH ASSEMBLY HAS ITS OWN RULE ABOUT WHETHER A TWO-THIRDS OR A SIMPLE MAJORITY VOTE IS NEEDED FOR AN ACTION.

THE COMMITTEE IS SUPPORTED BY THE GROUPS. BY THE YARD STICK OR RULE OF THE THUMB IT AMOUNTS TO \$1.00 PER MEMBER PER YEAR. THIS MONEY IS USED TO HELP DEFRAY EXPENSES OF THE DELEGATE GIVING HIS REPORT TO THE DISTRICTS AND OTHER GENERAL EXPENSE, SUCH AS PRINTING, MAILING AND ETC.

THERE IS NOTHING BETTER IN AA THAN BEING INFORMED AND THIS IS THE PURPOSE OF THE ASSEMBLY. YOUR GROUP NEEDS INFORMATION THE GSR ACQUIRES AT THE ASSEMBLY MEETING AND SHOULD REQUEST HIM TO GIVE SUCH A REPORT TO THE GROUP. THE MORE INTEREST THE GROUP SHOWS, THE MORE ENTHUSIASM THE GSR WILL HAVE.

CHAPTER EIGHT

DELEGATE

ONCE A YEAR, USUALLY IN MID-APRIL EACH AREA SENDS TO NEW
YORK A MEMBER TO MEET WITH THE STAFF OF GSO AND THE BOARD OF
TRUSTEES. THIS MEMBER'S OFFICE IN AA IS CALLED THE "DELEGATE."

A DELEGATE USUALLY IS A MEMBER WHO HAS SHOWN MUCH INTEREST IN SERVICE WORK. HE HAS HELD OFFICES IN HIS GROUP, HAS BEEN A COMMITTEE MEMBER. HE HAS GIVEN TIME AND EFFORT TO HELP SERVE HIS FELLOW ALCOHOLIC. HE HAS APPLIED THE SPIRITUAL FRINCIPLES OF AA TO HIS DAILY LIFE. A DELEGATE IS ELECTED FOR TWO YEARS.

THE DELEGATE'S JOB IS A DEMANDING ONE. HE OR SHE HAS MANY DUTIES. IN MID-APRIL HE PREPARES HIMSELF TO ATTEND THE NEW YORK GSO CONFERENCE. HE FINDS REAMS OF PAPER COMING THROUGH THE MAIL FOR HIM TO PREPARE HIMSELF FOR THE CONFERENCE. WHEN ARRIVING IN NEW YORK AT THE CONFERENCE HOTEL, HE IS ASSIGNED A ROOM. MOST LIKELY HE WILL ARRIVE A DAY EARLY AND WILL GO OVER TO SEE THE GENERAL SERVICE STAFF AND PERSONNEL AND MEET MANY OTHER DELEGATES FROM ALL OVER THE USA AND CANADA.

THE NEXT DAY THE CONFERENCE STARTS AND THEN FOR APPROX-IMATELY ONE WEEK HE IS ATTENDING MEETINGS OF SOME SORT FROM 9 A.M. TO 11 P.M., EATING TOGETHER, LIVING TOGETHER, ARGUING TOGETHER, WORKING TOGETHER WITH THE OTHER DELEGATES. ALL BUSINESS AT HAND IS DISCUSSED IN FULL AND REPORTS OF AA IN EVERY RESPECT ARE GIVEN BY THE PROPER PERSON. THE DELEGATE IS NOT AN INSTRUCTED MESSENGER TO THE CONFERENCE. A DELEGATE LISTENS TO WHAT IS SAID ON A SUBJECT AND MAKES HIS OWN JUDGEMENT. HE IS A SERVANT OF AA, AND WE CALL A SERVANT OF AA A TRUSTED SERVANT, NOT A MESSENGER.

WHEN ARRIVING HOME THE DELEGATE IMMEDIATELY PREPARES INFORMATION FOR THE AREA AND STARTS GIVING HIS REPORT TO EACH DISTRICT AS INVITED. HE IS EXPECTED TO TRANSMIT THE WORLD PICTURE TO THE COMMITTEE MEMBERS AND INSPIRE THEM TO PASS ON THIS INFORMATION TO GSRS AND GROUPS, AND TO THE INTER-GROUP OFFICERS.

THE DELEGATE ALSO PREPARES TO ATTEND AREA ASSEMBLIES.

FROM THESE ASSEMBLIES HE COMES TO UNDERSTAND THE PROBLEMS
IN HIS AREA. HE ATTENDS ALL LARGE GET-TOGETHERS OF AA MEMBERS
AND TALKS AND LISTENS TO UNDERSTAND THEIR PROBLEMS. HE HELPS
THE COMMITTEE MEMBERS OBTAIN FINANCIAL SUPPORT FOR GSO.

HE TELLS THE GSRS AT ASSEMBLIES WHAT TO EXPECT IN NEW CONFERENCE
LITERATURE AND ABOUT THE GRAPEVINE. HE CO-OPERATES WITH
THE GSO ON INFORMATION STUDIES FROM TIME TO TIME. HE PROVIDES
LEADERSHIP ON TRADITION BREAKS, VISITS GROUPS, DISTRICTS AND
AREAS, ALWAYS TAKING NOTES ON THE REACTIONS OF THE AA MEMBERS
ON ACTIONS TAKEN BY THE CONFERENCE AND REPORTING THE RESULTS
TO GSO.

HE SERVES AS CHAIRMAN OF THE ASSEMBLY OF THE CHAIRMAN IS
UNABLE TO ATTEND AND IS THE REFEREE IF ANY REFEREEING IS
NECCESSARY. ABOVE ALL HE IS CONSTANTLY SHARING HIS STRENGTH
AND HOPE WITH COMMITTEE MEMBERS AND GSRS THROUGHOUT THE
YEAR.

HE KEEPS THE ALTERNATE DELEGATE FULLY INFORMED, USING HIS HELP WHENEVER POSSIBLE, SO THE ALTERNATE CAN REPLACE HIM IN AN EMERGENCY.

LATE IN THE SECOND YEAR, HE HAS THE JOB OF WORKING WITH THE NEWLY ELECTED DELEGATE.-HIS SUCCESSOR.-TO GIVE HIM BASIC KNOWLEDGE OF CONFERENCE PROBLEMS AND PROCEDURES. AND LAST BUT NOT LEAST HE MAINTAINS COMMUNICATION DURING THE YEAR WITH GSO.

DELEGATE EXPENSES ARE PROVIDED BY THE COMMITTEE TREASURY.

THESE EXPENSES INCLUDE TRAVEL, TELEPHONE, POSTAGE, OUT OF

POCKET, HOUSING AND ETC. AS WE IN AA SAY, THE DELEGATE SHOULD

BE PRUDENT. FEW THINGS CAUSE MORE CONTROVERSY IN AA THAN

MONEY. A DELEGATE'S EXPENSES ARE NO EXCEPTION.

THE GSO OFFICE PAYS THE BALANCE OF A DELEGATE'S EXPENSES TO NEW YORK, AFTER THE DELEGATE'S AREA HAS PAID GSO THE SUM OF \$200.00. THIS GIVES THE DELEGATE MOST OF HIS EXPENSES. A DELEGATE IS USUALLY AN AA MEMBER WHO IS WELL ADJUSTED AND WELL MOTIVATED AND EXPENSES ARE NOT A BIG THING AS FAR AS HE IS CONCERNED.

WHAT MAKES A GOOD DELEGATE? AN AA MEMBER WHO IS AVAILABLE

AND HAS THE TIME TO SPEND SERVING AS A DELEGATE, WITHOUT
HURTING OR HINDERING HIS LIVELIHOOD. HE SHOULD HAVE SERVED
AS A GROUP SERVANT INCLUDING GSR, SERVED AS A COMMITTEE
MEMBER AND ENJOYED THE RESPONSIBILITIES.

THE DELEGATE SHOULD DISCUSS THE JOB WITH HIS FAMILY, BEING SURE THAT TIME IS AVAILABLE FOR THE AMOUNT OF WORK REQUIRED. HE SHOULD BE WELL TUTORED IN THE AA LITERATURE, SUCH AS, SERVICE MANUEL, AA COMES OF AGE, TWELVE STEPS, TWELVE TRADITIONS AND THE TWELVE CONCEPTS. HE SHOULD TALK TO THE PAST DELEGATES TO BE SURE HE KNOWS HOW MUCH TIME AND WORK IS INVOLVED.

THERE IS NO STANDARD TYPE WHO MAKES A DELEGATE. THEY COME
IN ALL SHAPES AND SIZES. THERE ARE SOME CHARACTERISTICS THAT
SEEM TO MAKE FOR BETTER QUALIFIED DELEGATES, AS THEY THEMSELVES
AGREE--OFTEN SEVERAL YEARS AFTER THEIR TERMS WHEN THEY CAN
MORE ACCURATELY MEASURE THE QUALITY OF THE JOB THEY TURNED IN.

- 1. AT LEAST SIX YEARS CONTINUOUS SOBRIETY
- 2. ABLE TO MAKE SUGGESTIONS
- 3. ABLE TO TAKE CRITICISM
- 4. KNOWLEDGE OF "ROBERT'S RULES OF ORDER"
- 5. DOES NOT FEEL THAT HE OR SHE IS THE "FINAL AUTHORITY"
- 6. KNOWLEDGEABLE ON THE TRADITIONS
- 7. LEADERSHIP ABILITY
- 8. CAN STIMULATE ACTION
- 9. OPEN-MINDED
- 10. ABLE TO DISCUSS AA MATTERS
- 11. KNOWS WHERE TO GET AA INFORMATION
- 12. HAS TIME TO CARRY OUT HIS OR HER DUTIES

DELEGATES ARE NOT POLITICAL. THEY RENDER SERVICE TO AA WORLD WIDE, TO INSURE THAT AA CONTINUES TO FUNCTION AS A WHOLE. DELEGATES ARE ALWAYS SERVANTS, NEVER SENATORS.

EACH AA MEMBER SHOULD HAVE THE OPPORTUNITY TO BECOME A DELEGATE, THERE FORE IT IS SUGGESTED THAT NO AA MEMBER CAN SERVE OVER TWO YEARS AS A DELEGATE, WITH THE EXCEPTION OF AN ALTERNATE DELEGATE. THE ALTERNATE DELEGATE MAY SERVE THE ONE YEAR REMAINING OF A DELEGATE AND THEN BE ELECTED TO A FULL TERM OF TWO YEARS.

A DELEGATE'S JOB IF DONE WELL IS NOT EASY. THERE IS MUCH
WORK TO BE DONE AT ALL LEVELS IN AA. CARRYING THE MESSAGE OF
GSO TO ALL IS A FULL TIME JOB. BUT IT IS WORTH ANY HARDSHIP THAT
MIGHT OCCUR. IN FACT IT IS A GOD GIVEN PRIVILEGE.

BERNARD B. SMITH, FORMER NON-ALCOHOLIC CHAIRMAN OF OUR BOARD OF TRUSTEES, AND ONE OF THE ARCHITECTS OF THE CONFERENCE STRUCTURE, SUPERBLY EXPLAINS THE CONFERENCE IN HIS OPENING TALK AT THE 1945 MEETING.

"WE MAY NOT NEED A GENERAL SERVICE CONFERENCE TO INSURE OUR OWN RECOVERY. WE DO NEED IT TO INSURE THE RECOVERY OF THE ALCOHOLIC WHO STILL STUMBLES IN THE DARKNESS ONE SHORT BLOCK FROM THIS ROOM. WE NEED IT TO INSURE THE RECOVERY OF A CHILD BEING BORN TONIGHT, DESTINED TO ALCOHOLISM. WE NEED IT TO PROVIDE, IN KEEPING WITH OUR TWELFTH STEP, A PERMANENT HAVEN FOR ALL ALCOHOLICS WHO, IN THE AGES AHEAD, CAN FIND IN AA THAT REBIRTH WHICH BROUGHT US BACK TO LIFE.

"WE NEED IT BECAUSE WE, MORE THAN ALL OTHERS ARE CONSCIOUS OF THE DEVASTATING EFFECT OF THE HUMAN URGE FOR POWER AND PRESTIGE WHICH WE MUST INSURE CAN NEVER INVADE AA. WE NEED IT

TO INSURE AA AGAINST GOVERNMENT, WHILE INSULATING IT AGAINST
ANARCHY; WE NEED IT TO PROTECT AA AGAINST DISINTEGRATION WHILE
PREVENTING OVER INTEGRATION. WE NEED IT SO THAT ALCOHOLICS
ANONYMOUS, AND ALCOHOLICS ANONYMOUS ALONE, IS THE ULTIMATE
REPOSITORY OF ITS TWELVE STEPS, ITS TWELVE TRADITIONS AND ALL
OF ITS SERVICES.

"WE NEED IT TO INSURE THAT CHANGES WITHIN AA COME ONLY AS A RESPONSE TO THE NEEDS AND THE WANTS OF ALL AA, AND NOT OF ANY FEW. WE NEED IT TO INSURE THAT THE DOORS OF THE HALLS OF AA NEVER HAVE LOCKS ON THEM, SO THAT ALL PEOPLE FOR ALL TIME WHO HAVE AN ALCOHOLIC PROBLEM MAY ENTER THESE HALLS UNASKED AND FEEL WELCOME. WE NEED IT TO INSURE THAT ALCOHOLICS ANONYMOUS NEVER ASKS OF ANYONE WHO NEEDS US WHAT HIS OR HER RACE IS, WHAT HIS OR HER CREED IS, WHAT HIS OR HER SOCIAL POSITION IS."

SO THAT IS THE DELEGATE, OUR TRUSTED SERVANT.

SUGGESTIONS FOR ORGANIZING AN ASSEMBLY EXCERPTS FROM THE SERVICE MANUEL, PAGES 49-50

THE DELEGATE IS ELECTED BY THIRD LEGACY PROCEDURE AS FOLLOWS:

- A. THE ELIGIBLE COMMITTEE MEMBERS STAND. THOSE ELIGIBLE MAY BE PAST OR PRESENT SOUTH FLORIDA COMMITTEE MEMBERS, OR BOTH.*
- B. THE CHAIRMAN ASKS IF ANYONE IS UNABLE TO SERVE: IF SO, THOSE SIT DOWN. #
- C. PAPER AND PENCILS ARE DISTRIBUTED FOR WRITTEN BALLOTS.

- D. SECRETARY CALLS THE ROLL OF VOTING MEMBERS. VOTING MEMBERS INCLUDE ALL GSRS(ONE FOR EACH GROUP), COMMITTEE MEMBERS OR ALTERNATES, AND OFFICERS.
- E. TWO NON-VOTING MEMBERS WILL BE SELECTED AS TELLERS, TWO AS COLLECTORS OF BALLOTS, AND ANOTHER TO RECORD AND TALLY VOTES ON THE BLACKBOARD (TOTAL 5).
- F. WRITTEN BALLOTS ARE CAST, COLLECTED AND GIVEN TO TELLERS TO COUNT.
- G. VOTE WILL BE WRITTEN ON BLACKBOARD ALONGSIDE NAMES OF CANDIDATES.
- H. THE FIRST CANDIDATE TO RECEIVE TWO-THIRDS VOTE IS ELECTED.
- I. AFTER THE SECOND BALLOT (ASSUMING NO CANDIDATE RECEIVES THE NECESSARY TWO-THIRDS ON FIRST BALLOT) ANY CANDIDATE HAVING LESS THAN ONE-FIFTH OF TOTAL VOTE WILL BE WITHDRAWN AUTO-MATICALLY, EXCEPT THAT THE TWO TOP CANDIDATES MUST REMAIN. (IN CASE THERE ARE TIES FOR SECOND PLACE, THE TOP CANDIDATE AND TIED SECOND-PLACE CANDIDATES REMAIN.)
- J. AFTER THE THIRD BALLOT, CANDIDATES WITH LESS THAN ONE-THIRD OF TOTAL VOTE WILL BE WITHDRAWN AUTOMATICALLY, EXCEPT THAT THE TWO TOP CANDIDATES MUST REMAIN. (IN CASE THERE ARE TIES FOR SECOND PLACE, THE TOP CANDIDATE AND TIED SECOND-PLACE CANDIDATES REMAIN.)
- K. A FOURTH BALLOT IS CONDUCTED.
- L. AFTER THE FOURTH BALLOT, IF NO CANDIDATE HAS TWO-THIRDS OF THE TOTAL VOTE, THE CHAIRMAN ASKS FOR A MOTION, SECOND AND MAJORITY OF HANDS ON CONDUCTION OF A FIFTH AND FINAL BALLOT. (IF THIS MOTION IS DEFEATED, BALLOTING IS OVER, AND WE GO TO THE "HAT" IMMEDIATELY. IF THE MOTION CARRIES, A FIFTH AND FINAL BALLOT WILL BE CONDUCTED.)
- M. IF NO ELECTION OCCURS BY THIS TIME, THE CHAIRMAN ANNOUNCES THE CHOICE WILL BE MADE BY LOT (FROM THE HAT.)
- N. LOTS ARE THEN DRAWN BY TELLER, AND FIRST ONE "OUT OF THE HAT" BECOMES THE DELEGATE.

THE ALTERNATE DELEGATE IS ELECTED NEXT, USING SAME PROCEDURE

CHAPTER NINE

GENERAL SERVICE BOARD

THE GENERAL SERVICE BOARD OF AA, INC., HAS BUT ONE PURPOSE,
THAT OF SERVING THE FELLOWSHIP OF ALCOHOLICS ANONYMOUS. IT IS
IN AN EFFECT AN AGENCY CREATED AND NOW DESIGNATED BY THE FELLOWSHIP OF ALCOHOLICS ANONYMOUS TO MAINTAIN SERVICES FOR THOSE WHO
SHOULD BE SEEKING, THROUGH AA, THE MEANS FOR ARRESTING THE DISEASE
OF ALCOHOLISM THROUGH THE APPLICATION TO THEIR OWN LIVES,
IN WHOLE OR IN PART, OF THE TWELVE STEPS WHICH CONSTITUTE THE
RECOVERY PROGRAM UPON WHICH THE FELLOWSHIP OF ALCOHOLICS
ANONYMOUS IS FOUNDED.

THE GENERAL SERVICE BOARD OF ALCOHOLICS ANONYMOUS CLAIMS

NO PROPREITARY RIGHTS IN THE RECOVERY PROGRAM, FOR THESE TWELVE

STEPS, AS ALL SPIRITUAL TRUTHS, MAY NOW BE REGARDED AS AVAILABLE

TO ALL MANKIND. HOWEVER, BECAUSE THESE TWELVE STEPS HAVE

PROVEN TO CONSTIUTE AN EFFECTIVE SPIRITUAL BASIS FOR LIFE WHICH,

IF FOLLOWED, ARRESTS THE DISEASE OF ALCOHOLICM, THE GENERAL

SERVICE BOARD ASSERTS THE NEGATIVE RIGHT OF PREVENTING, SO FAR

AS IT MAY WITHIN ITS POWER TO DO SO, ANY DISTORTIONS OR CHANGES

OR EXTENSION OF THESE TWELVE STEPS, EXCEPT AT THE INSISTANCE OF THE

FELLOWSHIP OF ALCOHOLICS ANONYMOUS IN KEEPING WITH THE CHARTER

OF THE GENERAL SERVICE CONFERENCE OF ALCOHOLICS ANONYMOUS AS

THE SAME MAY FROM TIME TO TIME BE AMENDED. THE GENERAL SERVICE BOARD IN ITS DELIBERATIONS AND DECISIONS SHALL BE GUIDED BY THE TWELVE TRADITIONS OF ALCOHOLICS ANONYMOUS.

THE MEMBERS OF THE GENERAL SERVICE BOARD ARE CALLED "TRUSTEES"
THERE ARE 14 MEMBERS OR TRUSTEES BELONGING TO THE FELLOWSHIP
OF ALCOHOLICS ANONYMOUS OR SO CALLED EX-ALCOHOLIC MEMBERS.
THERE WILL BE 7 MEMBERS OR TRUSTEES CALLED NON-ALCOHOLICS. THE
NON-ALCOHOLIC TRUSTEES ARE KNOWN AS CLASS B TRUSTEES. CLASS A
TRUSTEES SERVE THE BOARD FOR THREE YEARS, CONFIRMED ANNUALLY.
THE CLASS B TRUSTEES SERVE THE BOARD 4 YEARS, AND ARE INELIGIBLE TO
SERVE LONGER. ALL TRUSTEES ARE ELECTED AND REELECTED ANNUALLY.

THE CLASS B TRUSTEES, 14 IN NUMBER ARE DIVIDED IN TWO CATEGORIES: EIGHT SHALL BE CLASSIFIED AS "REGIONAL TRUSTEES", SIX SHALL BE CLASSIFIED AS GENERAL SERVICE TRUSTEES. OF THE GENERAL SERVICE TRUSTEES, FOUR SHALL BE FROM NEW YORK COMMUTING AREA, ONE FROM CANADA AND ONE FROM THE UNITED STATES. THE CLASS B REGIONAL TRUSTEES ARE EXPECTED TO CONTRIBUTE THEIR TIME BASICALLY DURING THE FOUR PERIODS OF THE YEAR, EACH THREE DAY PERIOD ENDING ON THE DAY OF EACH QUARTERLY MEETING OF THE TRUSTEES OF THE GENERAL SERVICE BOARD, AND, IN ADDITION, TO ADVISE THE BOARD WITH RESPECT TO REGIONAL VIEWS AND OPINIONS REGARDING POLICY MATTERS. THE REGIONAL TRUSTEES ARE EXPECTED TO PROVIDE CONTINUED SERVICE TO THE BOARD DURING ALL OF THE TIMES OF THE YEAR.

HOW ARE THE CLASS B TRUSTEES ELECTED TO THE BOARD? THE

ELECTORAL MAP OF THE USA AND CANADA OUTLINES THE BOUNDARIES
OF EACH TRUSTEE, 8 IN NUMBER. EACH AREA IS ENTITLED TO SELECT
FROM ITS MEMBERS A CANDIDATE FOR THE GENERAL SERVICE BOARD.
THEY SUBMIT TO THE GENERAL SERVICE OFFICE THEIR SELECTION, WITH
QUALIFICATIONS. THE GSO THEN PASSES ON THIS INFORMATION TO THE
GENERAL SERVICE BOARD NOMINATING COMMITTEE. IN TURN TRUSTEES
ARE ELECTED THROUGH THE 3rd LEGACY PROCEDURE.

THE FOUR SO-CALLED GENERAL SERVICE NEW YORK TRUSTEES ARE CHOSEN FROM TWO OPERATING BOARDS WHICH WE WILL DISCUSS LATER, NAMELY AA WORLD SERVICES, INC. AND THE AA GRAPEVINE, INC.



THE GENERAL SERVICE OFFICE, TO BE KNOWN HENCEFORTH AS GSO, IS LOCATED IN NEW YORK CITY, AND HAS BEEN SINCE ITS BEGINNING.

THE BEST EXPLANATION OF GSO IS, "IT IS A CLEARING HOUSE FOR ALCOHOLICS ANONYMOUS." IT IS WHERE WE KEEP THE ARCHIVES OF AA, IT IS WHERE ALL ACTIVITY OF AA AT WORLD LEVEL IS ADMINISTERED.

HERE ARE A FEW THINGS THAT THE GSO DOES:

THE STRUCTURE OF GSO IS AS FOLLOWS: THE BOARD IS RESPONSIBLE FOR GSO, AND IT TAKES CARE OF ITS ADMINISTRATIVE DUTIES THROUGH TWO OPERATING CORPORATIONS. ONE IS THE AA WORLD SERVICES, INC., WHICH HANDLES WORLD SERVICE OR GENERAL SERVICES, AND THE PUBLISHING OF BOOKS AND PAMPHLETS. THE OTHER IS THE AA GRAPEVINE, INC., WHICH DOES THE EDITING, PUBLISHING, AND DISTRIBUTING OF

THE AA GRAPEVINE.

THE BOARD OF TRUSTEES "OWNS BOTH OF THESE SERVICE CORPORATIONS AND ELECTS THE DIRECTORS OF EACH. WHILE THE BOARD DOES
NOT INTERFERE WITH THE DAILY OPERATION OF EITHER CORPORATION,
IT RECOGNIZES ITS OWN ULTIMATE RESPONSIBILITY FOR SEEING THAT BOTH
OPERATE IN THE BEST INTEREST OF THE MOVEMENT AS A WHOLE.

AA WORLD SERVICES, INC. HAS SEVEN DIRECTORS, ONLY TWO OR THREE OF WHOM ARE TRUSTEES. THERE ARE VOLUNTEERS, EXPERTS IN OFFICE MANAGEMENT AND PUBLISHING, ONE IS A PAID STAFF MEMBER AND THE OTHER IS THE GENERAL MANAGER OF THE GSO.

SIMILARLY, AA GRAPEVINE, INC. DIRECTORS ARE TRUSTEES, VOL-UNTEERS AND PAID STAFF MEMBERS. IN THE CASE OF AA WORLD SERVICE, INC., ITS PRESIDENT IS THE GENERAL MANAGER AND CHAIRMAN OF GENERAL SERVICES. THIS SYSTEM HAS PROVEN CORRECT.

AS WE ALREADY KNOW, AA PUBLISHES ALL ITS BOOKS AND LITERATURE.

WHEN NEW MATERIALS ARE NEEDED, WORK IS STARTED. FIRST THE WRITING

ALL BOOKS HAVE BEEN WRITTEN BY BILL WILSON AS TO THIS DATE.

ALL PAMPHLETS HAVE BEEN WRITTEN BY AA'S WHO TOOK GREAT

PAINS TO GATHER THEIR MATERIAL FROM ALL OVER THE MOVEMENT.

FROM THE FIRST DRAFT TO THE LAST, COMMITTEE AND STAFF MEMBERS,

AND SPECIAL PANELS, ARE FREE TO CRITICIZE AND SUGGEST, UNDER
LINING WHAT THEY FEEL WILL BEST EXPRESS THE AA POINT OF VIEW.

THIS PROCESS TAKES MONTHS OR YEARS, BUT THE RESULTS ARE WORTH

THE EFFORT. WHEN THE PAMPHLET IS FINALLY COMPLETED, IT IS

ENTITLED TO CARRY THE "CONFERENCE APPROVED" SEAL, HAVING

FULLY EARNED IT.

THE GSO IS THE HEART OF OUR FELLOWSHIP. ANYTIME, ANYWHERE, A MEMBER OF AA WANTS TO ASK QUESTIONS ABOUT THE PROGRAM OR ITS SERVICES, A LETTER TO P.O. BOX 459, GRAND CENTRAL STATION, NEW YORK, NEW YORK 10017, WILL BRING THE ANSWER. THERE IS NO REASON THAT A MEMBER OF AA SHOULD NOT BE INFORMED.

HOW IS THE GSO SUPPORTED? THE MEMBERS ALONE SUPPORT THE GSO.
THE SUGGESTED AMOUNT OF EACH MEMBER IS ONE CENT A DAY OR \$3.65
PER YEAR. IN OUR TRADITIONS WE KNOW THAT AA DECLINES ALL CONTRIBUTIONS OUTSIDE AA. THEREFORE, WE AS INDIVIDUAL MEMBERS SHOULD ALWAYS REMEMBER OUR RESPONSIBILITIES AND BE SURE THEY ARE MET.
THERE IS ANOTHER COURSE OF INCOME AND THAT IS THE PROFIT ON BOOKS AND LITERATURE. LET IT BE KNOWN FOREVER THAT ALCOHOLICS

CHAPTER ELEVEN

CLUBS

"FROM AA'S BEGINNING, THE GROUP HAS BEEN THE MAINSPRING IN CARRYING OUT THE PRIMARY PURPOSE OF AA--TO 'CARRY THE MESSAGE TO THE ALCOHOLIC WHO STILL SUFFERS.' IT IS IN THE GROUP WHERE AAS RECOVER, LEARN TO LIVE TOGETHER IN UNITY AND GROW SPIRIT-UALLY THROUGH SERVICE. THUS, AA MEMBERS AROUND THE WORLD ZEALOUSLY (AND EVEN JEALOUSLY) GUARD THE GROUP BECAUSE IT IS THE VERY CORE OF OUR SOBER LIVES TODAY--THE PLACE WHERE WE LIVE AND WORK TOGETHER, EVER MINDFUL OF OUR COMMON WELFARE.

THE AA GROUP IS NOT ONLY AA TO MEMBERS BUT ALSO TO OUR NONAA FRIENDS. THUS, ANY OTHER SERVICE ENTITY WHICH COMES ABOUT
THROUGH A NEED SHOULD SO CONDUCT ITS AFFAIRS THAT IT WILL REFLECT
FAVORABLY ON THE AA GROUP, SO THAT THE MESSAGE WILL CONTINUE
TO BE CARRIED AND EACH AA WILL HAVE THE OPPORTUNITIES FOR
SERVICE WHICH COME FROM GROUP ACTIVITIES.

DURING THE PAST THIRTY-FIVE YEARS, THE CLUB IDEA HAS BECOME
A PART OF AA. THIS IS EASY TO UNDERSTAND BECAUSE THE GROUP
MAY HAVE FELT THE NEED FOR A PERMANENT MEETING PLACE (A HOME
SO TO SPEAK) AND A PLACE WHERE NEW MEMBERS COULD GO FOR COFFEE
AND CONVERSATION; A SPOT WHERE MEMBERS COULD GATHER FOR LUNCH;
A PLACE WHERE THEY COULD GATHER SOCIALLY ON WEEKENDS AND

HOLIDAYS. FOR IT SEEMS THAT SOME AAS IN THEIR NEW-FOUND WAY

OF LIFE WISH MORE THAN THE GROUP MEETINGS; THEY WANT AA SOCIAL

LIFE, TOO. THUS, THE CLUB IDEA WAS BORN.

HOWEVER, THERE HAVE ALWAYS BEEN AAS WHO HAVE NOT FELT
THE NEED OF A CLUB BECAUSE THEY HAVE FOUND THE GROUP SUFFICIENT
FOR THEIR AA NEEDS. THUS, CLUBS ARE DESIGNED FOR THOSE WHO
WISH THEM AND ALL PLANS SHOULD BE MADE ACCORDINGLY--ALWAYS
ENCOURAGING AA GROUP PARTICIPATION BY THEIR MEMBERS.

HERE ARE SOME SUGGESTIONS WHICH COME FROM THE EXPERIENCE OF OTHER CLUBS:

1. EVEN THOUGH WE KNOW THAT THERE IS NO 'AA CLUB'--MANY THINK OF THE CLUB AS AA, PARTICULARLY THE NON-AAS IN YOUR COMMUNITY. THEREFORE, IT IS SUGGESTED THAT YOU FAMILIARIZE YOURSELF WITH AA'S TWELVE TRADITIONS--AND GUIDE CLUB MATTERS IN KEEPING WITH THESE TRADITIONS. SO WHILE THE CLUB MAY BE CALLED 'ARID' OR 'ANSA' OR 'ANCHOR' OR SOME NAME THAT DOES NOT INVOLVE AA, THE MEMBERS STICK CAREFULLY TO AA TRADITIONS AND ACCEPT NO FUNDS FROM OUTSIDE THE AA MEMBERSHIP. DUES AND CONTRIBUTIONS KEEP THE CLUB GOING--PLUS RENT MONEY RECEIVED FROM ONE OR MORE AA GROUPS WHICH MAY HOLD THEIR MEETING IN THE CLUB.

FREQUENTLY THERE IS A TEMPTATION TO ACCEPT BUILDING MATERIALS, FURNITURE, KITCHEN EQUIPMENT AND SUPPLIES FROM WELL-MEANING, CIVIC-MINDED NON-AAS. THEN EVERYONE IN THE CLUB SHOULD BE AWARE OF THE VALUE OF THE SELF-SUPPORT TRADITION--THE ONE THAT HAS BROUGHT US ALONG TO THIS POINT COMPLETELY INDEPENDENT AND FINANCIALLY SOUND. IT WILL NOT ALWAYS BE EASY TO ASSUME ALL YOUR FINANCIAL RESPONSIBILITIES BUT IT WILL BE MORE SATISFYING.

- 2. DETERMINE THE AMOUNT OF MONEY NEEDED FOR SUCH AN OPERATION AND WORK OUT A BUDGET WHICH WILL COVER YOUR GETTING STARTED, YOUR RENT, UTILITIES, CUSTODIAL CARE, AND ANY OTHER KNOWN EXPENSES.
- 3. CALL A MEETING OF ALL AAS SEPARATE FROM AN AA GROUP MEETING AND INFORM THEM OF PLANS, THE FINANCIAL NEEDS, AND DETERMINE HOW MANY DUES-PAYING MEMBERS YOU CAN COUNT ON FROM THE BEGINNING. ALSO, ASK THE GROUP OR GROUPS IF THEY WOULD BE

INTERESTED IN USING THE CLUB FOR MEETINGS AND, IF SO, HOW MUCH RENT THEY WOULD CONSIDER REASONABLE. SOMETIMES, CHARTER MEMBERS ARE WILLING TO PAY A LITTLE MORE IN THE BEGINNING TO HELP GET THE CLUB OFF THE GROUND. IT SEEMS BETTER TO ASK ALL TO PARTICIPATE IN THIS FINANCING THAN FOR ONE OR TWO WEALTHIER AAS TO ASSUME THIS RESPONSIBILITY. YOU MAY NOT WISH TO HAVE A FEW AAS FEEL THAT THEY HAVE A VESTED INTEREST IN THE CLUB. LET EVERYONE PARTICIPATE WHO WANTS TO. MONTHLY DUES SEEM TO RANGE FROM \$3 TO \$10 DEPENDING ON TYPE AND NEED OF CLUB.

- 4. CLUB DIRECTORS: WHO WILL SERVE AS DIRECTORS? WHAT SHOULD THIER QUALIFICATIONS BE? DIRECTORS' RESPONSIBILITY INVOLVES THE HANDLING OF THE BUSINESS AFFAIRS OF THE CLUB. THEY HOLD THE LEASE AND PAY ALL BILLS FOR MAINTENANCE OF THE PROPERTY. MANY CLUBS REQUIRE APPROXIMATELY THREE YEARS SOBRIETY FOR DIRECTORS AND FOLLOW THE SUGGESTION THAT CLUB DIRECTORS SHOULD NOT HOLD OFFICES IN THE AA GROUP MEETING IN THE CLUB OR IN ANY OTHER AA SERVICE GROUP.
- 5. QUALIFICATIONS FOR CLUB MEMBERSHIP: MOST CLUBS STATE THAT 'ANY AA INTERESTED IN A CLUB IS ESIGIBLE FOR MEMBERSHIP. MOST REQUIRE THIRTY DAYS OF SOBRIETY, WHILE A FEW REQUIRE NINETY DAYS. DURING THESE PERIODS, HOWEVER NEW AAS CAN USE THE CLUB FACILITIES AS GUESTS.' ALL DUES-PAYING MEMBERS WOULD NORMALLY BE ELIGIBLE TO HOLD OFFICE AND TO VOTE AT THE CLUB BUSINESS MEETINGS.
- 6. CONSULT A LAWYER AND HAVE THE CLUB INCORPORATED AS A NON-PROFIT BUSINESS ORGANIZATION, UNDER THE RULES OF THE STATE IN WHICH IT WILL FUNCTION. USUALLY, A LAWYER, WHO IS AN AA MEMBER IS AVAILABLE TO ADVISE ON THIS SUBJECT AND IT SHOULD NOT BE A VERY COMPLICATED OR EXPENSIVE PROJECT. INCORPORATION IS IN ACCORDANCE WITH TRADITION SIX WHICH SUGGESTS THAT PROPERTY TO BE USED BY AAS BE SEPARATELY INCORPORATED AND MANAGED, LEST PROBLEMS OF MONEY, PRESTIGE AND PROPERTY DIVERT AA FROM ITS PRIMARY PURPOSE. NEEDLESS TO SAY, A CLUB SO INCORPORATED SHOULD NOT HAVE 'AA' IN ITS NAME.
- 7. AFTER THE CLUB IS INCORPORATED THE DIRECTORS DETERMINE DETAILS OF CLUB OPERATION. THIS MIGHT BE FOLLOWED BY A MEETING OF DUES-PAYING MEMBERS TO OBTAIN THEIR APPROVAL OF YOUR OVERALL PLANS, CLUB RULES, ETC. ALL BY-LAWS AND RULES CAN BE CHANGED LATER, OF COURSE, AS EXPERIENCE IS PILED UP.
- 8. GAMBLING AND CARD-PLAYING SHOULD BE GIVEN A GREAT DEAL OF THOUGHT IN THE BEGINNING. MUCH DIFFICULTY HAS ARISEN OVER BOTH IN CLUBS NOW FUNCTIONING, AND MANY WHO ORIGINALLY HAD BOTH HAVE DISCONTINUED THEM BECAUSE OF INCIDENTS WHICH HURT THE CLUB.

- 9. EXPERIENCE PROVES THAT INTERGROUP OR CENTRAL OFFICES OR CENTRAL SERVICE COMMITTEES SHOULD BE SEPARATE FROM CLUBS-PHYSICALLY SEPARATE AND SEPARATE AS FAR AS ADMINISTRATION IS CONCERNED. IN SOME CASES, A NEWLY FORMED INTERGROUP OR CENTRAL OFFICE IS INVITED TO USE CLUB FACILITIES. AT THAT POINT, AAS SHOULD TAKE A GOOD LOOK AT TRADITIONS AND REMEMBER THAT A SERVICE OFFICE IS RESPONSIBLE TO ALL AA WHILE A CLUB IS THE RESPONSIBILITY OF THE DUES-PAYING MEMBERS ONLY. GENEROUS AS THE OFFER MAY APPEAR, A SERVICE OFFICE IS WELL ADVISED TO MAINTAIN ITS OWN QUARTERS AND ITS OWN OFFICERS.
- 10. IN THE EVENT AL-ANON WISHES TO USE CLUB FACILITIES FOR MEETINGS, IT IS SUGGESTED THAT RENT BE CHARGED AS IT IS TO ANY GROUP USING THE CLUB FACILITIES FOR ITS MEETINGS.

ALTHOUGH THERE IS NO SUCH THING AS AN 'AA CLUB' MANY CLUBS HAVE BEEN IDENTIFIED WITH AA BECAUSE THEY ARE ORGANIZED AND DIRECTED BY AA MEMBERS AND MEMBERSHIP IS LIMITED TO AAS.

CLUBS WHERE MEETINGS ARE HELD AND WHICH ARE MAINTAINED FOR TWELFTH STEP AS WELL AS SOCIAL PURPOSES CAN AVOID DIFFICULTIES BY ABIDING BY AA TRADITIONS. THEY SHOULD NOT USE THE AA NAME, HOWEVER, AND SHOULD BE ORGANIZED APART FROM AA. THEY SHOULD NOT ACCEPT MONEY FROM OUTSIDE SOURCES, BUT BE SUPPORTED BY MEMBERSHIP DUES AND INDIVIDUAL CONTRIBUTIONS FROM AA MEMBERS. THE QUESTION OF A PAID MEMBERSHIP IN AA SHOULD NOT ARISE, SINCE AA MEETINGS HELD IN CLUBS ARE OPEN TO ALL. THE CONFERENCE VOICED RECOGNITION OF THE FACT THAT CLUBS SHOULD OPERATE WITHIN AA TRADITIONS AND ABIDE BY THEM TO THE FULLEST."

SAMPLE CHARTER

NON-PROFIT BUSINESS ORGANIZATION CHARTER AS FILED WITH THE STATE
OF FLORIDA WHEN THIS CLUB CAME INTO BEING, THEIR BY-LAWS HAVE
BEEN CHANGED.

ARTICLE I

THE NAME OF THIS ORGANIZATION SHALL BE "THE 101 FRATERNITY, INCORPORATED". LOCATED IN POMPANO BEACH, FLORIDA.

ARTICLE II

THE OBJECTS OF THIS FRATERNITY SHALL BE:

- A. A SOCIAL FRATERNITY FOR SOBER ALCOHOLICS.
- B. TO ASSIST IN THE REHABILITATION OF ACTIVE ALCOHOLICS.

ARTICLE III - MEMBERSHIP

SECTION 1 - THE CLASSIFICATION OF MEMBERS SHALL BE

- A. ACTIVE MEMBERS SHALL:
 - 1. BE ENTITLED TO ALL THE PRIVILEGES OF THE FRATERNITY.
 - 2. SERVE ON ANY COMMITTEE TO WHICH HE OR SHE IS APPOINTED BY THE CHAIRMAN OF THE BOARD OF DIRECTORS.
- B. INACTIVE MEMBERS SHALL BE:
 - 1. ANY MEMBER WHO LOSES HIS OR HER SOBRIETY.
- SECTION 2 THE MEMBERSHIP SHALL BE COMPOSED OF SOBER MEN AND WOMEN ALCOHOLICS WITH A MINIMUM OF 30 DAYS SOBRIETY.
- SECTION 3 APPLICANTS FOR MEMBERSHIP:
 - A. ANY SOBER ALCOHOLIC WITH 30 DAYS OF CONTINUOUS SOBRIETY SHALL BE ELIGIBLE FOR MEMBERSHIP.

B. ANY SUCH PERSON SHALL BECOME A MEMBER BY NOTIFYING THE CLUB SECRETARY OF HIS DESIRE TO BECOME A MEMBER AND BY PAYING THE TREASURER ONE MONTH'S DUES IN ADVANCE.

SECTION 4 - RESIGNATIONS FROM MEMBERSHIP.

- A. ANY PERSON MAY RESIGN BY NOTIFYING THE SECRETARY TO DROP HIS NAME FROM THE MEMBERSHIP ROLLS.
- B. ANY MEMBER WHO LOSES HIS SOBRIETY AND USES HIS KEY WHILE INTOXICATED TO ENTER THE PREMISES SHALL BE AUTOMATICALLY DROPPED FROM THE ROLLS AND HE SHALL FORFEIT HIS KEY UNTIL REINSTATED.
- C. ANY MEMBER WHO IS TWO MONTHS IN ARREARS OF HIS DUES SHALL BE AUTOMATICALLY DROPPED FROM THE MEMBERSHIP ROLLS.

SECTION 5 - REINSTATEMENT OF MEMBERSHIP.

- A. ANY PERSON DROPPED FROM MEMBERSHIP FOR DELINQUENT DUES SHALL BE REINSTATED UPON PAYMENT OF TWO MONTHS DUES HE IS IN ARREARS PLUS THE CURRENT MONTHS DUES.
- B. ANY PERSON WHO LOSES HIS SOBRIETY MAY BE REINSTATED AS ABOVE IN "A" AFTER 30 DAYS OF CONTINUOUS SOBRIETY.

ARTICLE IV - DUES

- SECTION 1 THE DUES OF THIS FRATERNITY SHALL BE TWO (\$2.00)
 DOLLARS PER MONTH FOR EACH ACTIVE MEMBER.
 - A. DUES ARE DUE AND PAYABLE ON OR BEFORE THE 1ST DAY OF EACH MONTH.
 - B. DUES SHALL BE PAID TO THE TREASURER WHO SHALL ISSUE RECEIPT FOR SAME.

ARTICLE V - MEETINGS

SECTION 1 - THE MEETINGS SHALL BE

A. REGULAR

- 1. REGULAR MEETING SHALL BE HELD QUARTERLY AT THE FRAT-ERNITY ADDRESS ON THE 1ST SUNDAY IN APRIL AND ON THE 1ST SUNDAY OF EACH THIRD MONTH THEREAFTER.
- 2. NOTICE OF SUCH MEETINGS SHALL BE POSTED ON THE BULLETIN BOARD 5 DAYS PRIOR TO SUCH MEETING AND EACH MEMBER NOTIFIED THERE OF AS HEREINAFTER SET FORTH UNDER ARTICLE VI.

B. CALL

- 1. CALL MEETINGS MAY BE HELD AT ANY TIME BY THE BOARD OF DIRECTORS.
- 2. BY 5 ACTIVE MEMBERS SIGNING A REQUEST AND FILING SAME WITH THE SECRETARY.
- 3. NOTICE OF CALL MEETINGS SHALL BE POSTED ON THE BULLETIN BOARD AS SOON AS THE DATE AND TIME CAN BE DETERMINED AND EACH MEMBER NOTIFIED AS IN ARTICLE VI.
- C. THE ANNUAL MEETING SHALL BE THE 1ST SUNDAY IN
 1963 AND ON THE SAME SUNDAY IN EACH YEAR THEREAFTER.

ARTICLE VI

SECTION 1 - NOTICE OF MEETINGS.

- A. ACTUAL NOTICE SHALL BE GIVEN BY ONE MEMBER TELLING ANOTHER OF THE TIME AND PLACE OF THE MEETING IN QUESTION. THIS MAY BE DONE EITHER IN PERSON OR BY PHONE.
- B. CONSTRUCTIVE NOTICE SHALL BE GIVEN BY MAILING A NOTE TO THE MEMBER STATING THE TIME, PLACE AND PURPOSE OF SUCH MEETING-SUCH NOTE MUST BE MAILED 2 DAYS PRIOR TO THE DATE OF SUCH MEETINGS. THE ADDRESS AS IT APPEARS ON THE MEMBER-SHIP ROLL IS SUFFICIENT FOR THIS PURPOSE. CONSTRUCTIVE NOTICE IS VALID EVEN THOUGH THE MEMBER DOES NOT RECEIVE SAME.
- C. NOTICE OF ANY MEETING IS SUFFICIENT IF EITHER ACTUAL OR CONSTRUCTIVE.

ARTICLE VIII- QUORUM AND ELECTION OF BOARD OF DIRECTORS

- SECTION 1 A QUORUM SHALL BE A MAJORITY OF THOSE PRESENT.
- SECTION 2 ANY BUSINESS CONDUCTED SHALL BE DECIDED BY A MAJORITY OF THE ACTIVE MEMBERS PRESENT AND VOTING.
- SECTION 3 THE BOARD OF DIRECTORS SHALL BE ELECTED BY SECRET BALLOT.

ARTICLE VIII--OFFICERS AND THEIR ELECTION

SECTION 1 - THE OFFICERS OF THIS FRATERNITY SHALL BE:

- A. CHAIRMAN OF THE BOARD OF DIRECTORS.
- B. VICE-CHAIRMAN OF THE BOARD OF DIRECTORS.

- C. SECRETARY) SECRETARY AND TREASURER MAY BE THE SAME PERSON AT THE DISCRETION OF THE BOARD OF
- D. TREASURER) DIRECTORS.
- SECTION 2 THE BOARD OF DIRECTORS SHALL DETERMINE THE OFFICERS FOR EACH QUARTER AT THE FIRST BOARD OF DIRECTORS MEETING FOLLOWING THE REGULAR QUARTERLY MEMBER-SHIP MEETING. THE SECRETARY AND/OR THE TREASURER NEED NOT BE MEMBERS OF THE BOARD OF DIRECTORS AND MAY SUCCEED THEMSELVES IN OFFICE.
- SECTION 3 TWO MEMBERS OF THE BOARD OF DIRECTORS SHALL BE ELECTED AT THE REGULAR MEMBERSHIP MEETING ON THE 1ST SUNDAY IN 196, AND 3 MEMBERS OF THE BOARD AT THE NEXT REGULAR MEETING.
- SECTION 4 THE MEMBERS OF THE BOARD SHALL SERVE FOR TWO QUARTERS AND CANNOT SUCCEED THEMSELVES IN OFFICE.
- SECTION 5 ANY ACTIVE MEMBER IS ELIGIBLE TO SERVE ON THE BOARD OF DIRECTORS
 - SECTION 6 ANY VACANCY ON THE BOARD WHICH OCCURS BETWEEN QUARTERLY MEETINGS OF THE MEMBERSHIP MAY BE FILLED BY A MAJORITY OF THOSE REMAINING ON THE BOARD NAMING A REPLACEMENT MEMBER TO SERVE UNTIL THE NEXT REGULAR MEETING. SUCH VACANCY SHALL BE FILLED BY THE MEMBER-SHIP AT ITS NEXT REGULAR MEETING.
 - SECTION 7 NEWLY ELECTED DIRECTORS SHALL ASSUME THEIR DUTIES IMMEDIATELY UPON ELECTION.

ARTICLE IX - DUTIES OF OFFICERS

- SECTION 1 CHAIRMAN OF THE BOARD
 - A. PRESIDE AT ALL MEETINGS.
 - B. APPOINT ALL COMMITTEES.
- SECTION 2 VICE-CHAIRMAN OF THE BOARD.
 - A. TO ASSIST THE CHAIRMAN IN HIS DUTIES.
 - B. TO ASSUME ALL THE DUTIES OF THE CHAIRMAN OF THE BOARD IN THE ABSENCE OF THE CHAIRMAN.
- SECTION 3 SECRETARY
 - A. TO MAINTAIN THE MEMBERSHIP ROLLS UP TO DATE.

CHAPTER TWELVE

AL-ANON

"THE FELLOWSHIPS OF ALCOHOLICS ANONYMOUS AND THE AL-ANON
FAMILY GROUPS HAVE A UNIQUE RELATIONSHIP. THEY ARE NATURALLY
DRAWN TOGETHER BY THEIR CLOSE FAMILY TIES. AND YET, THE
TWELVE TRADITIONS, THE GENERAL SERVICE BOARDS, AND THE GENERAL
SERVICE CONFERENCES OF BOTH FELLOWSHIPS SUGGEST THAT EACH
FUNCTIONS MORE EFFECTIVELY IF IT REMAINS 'SEPARATE,' CO-OPERATING
BUT NOT AFFILIATING WITH THE OTHER.

EACH FELLOWSHIP HAS ALWAYS HAD ITS OWN GENERAL SERVICE BOARD, GENERAL SERVICE OFFICE, CONFERENCE, PUBLISHING COMPANY AND WORLD DIRECTORY. EACH HAS ESTABLISHED ITS OWN POLICIES AND MAINTAINED ITS OWN SERVICES. THIS SEPARATE FUNCTIONING HAS SERVED BOTH AA AND AL-ANON FAMILY GROUPS WELL. AS A MATTER OF FACT, AA'S POLICY OF 'CO-OPERATION BUT NOT AFFILIATION' WAS ESTABLISHED AS LONG AGO AS THE EARLY 1950'S, AND BOTH AL-ANON AND AA RECOGNIZED AT THAT TIME THE IMPORTANCE OF MAINTAINING SEPARATE FELLOWSHIPS.

HOWEVER, FROM TIME TO TIME, QUESTIONS COME TO BOTH AA AND AL-ANON GENERAL SERVICE OFFICES INDICATING CONFUSION AS TO HOW AA AND AL-ANON MAY BEST CO-OPERATE IN THE AREA OF GROUPS, INTERGROUPS OR CENTRAL SERVICES AND AREA AND REGIONAL CONVENTIONS

AND GET-TOGETHERS.

THE STAFF MEMBERS OF THE GENERAL SERVICE OFFICES OF AA

AND AL-ANON MET AND DISCUSSED THESE QUESTIONS AND AA'S GENERAL

SERVICE CONFERENCE APPROVED THE FOLLOWING SUGGESTED GUIDE
LINES:

QUESTION: SHOULD A GROUP BE AFFILIATED WITH BOTH AA AND AL-ANON?

ANSWER: AS THE PRIMARY PURPOSE OF THE AA GROUP IS TO HELP
THE SICK ALCOHOLIC TO RECOVER AND THE PRIMARY PURPOSE OF THE
AL-ANON FAMILY GROUPS IS TO HELP THE AL-ANON TO LIVE WITH HIMSELF
OR HERSELF AS WELL AS WITH THE ALCOHOLIC, IT WAS SUGGESTED THEY
NOT BE COMBINED BUT REMAIN SEPARATE GROUPS. THIS WILL ENABLE
BOTH FELLOWSHIPS TO FUNCTION WITHIN THEIR TWELVE TRADITIONS
AND TO CARRY THEIR MESSAGE MORE EFFECTIVELY. THUS, THE GROUP
NAME, THE OFFICERS AND THE MEETING SHOULD BE EITHER AA OR ALANON BUT NOT BOTH. NATURALLY, ALL ARE WELCOME AT OPEN MEETINGS
OF BOTH AA AND AL-ANON GROUPS.

QUESTION: SHOULD AA AND AL-ANON HAVE COMBINED CENTRAL (OR INTERGROUP) SERVICES AND OFFICES?

ANSWER: BOTH EXPERIENCE AND THE TWELVE TRADITIONS OF AA AND AL-ANON SUGGEST THAT EACH FELLOWSHIP WILL FUNCTION MORE EFFECTIVELY IF EACH RETAINS SEPARATE COMMITTEES, SEPARATE STAFFS AND FACILITIES FOR HANDLING TELEPHONE AND PERSONAL CALLS, AS WELL AS SEPARATE TELEPHONE ANSWERING SERVICES, INTERGROUP

ACTIVITIES, BULLETINS, MEETING LISTS AND ALL TYPES OF TWELFTA STEP SERVICES. ALSO, THAT THE MEMBERS INVOLVED IN EACH SERVICE COMMITTEE OR OFFICE BE AA MEMBERS, IF AN AA FACILITY, AND AL-ANON, IF AN AL-ANON FACILITY.

QUESTION: HOW MAY AA AND AL-ANON CO-OPERATE IN AREA AND REGIONAL CONVENTIONS AND GET-TOGETHERS?

ANSWER: THIS ANSWER DEPENDS ON WHETHER IT IS AN AA CONVENTION OR AN AL-ANON CONVENTION. THE FORMER ARE GROWING IN NUMBER.

IN ACCORDANCE WITH THE TWELVE TRADITIONS, A CONVENTION

WOULD BE EITHER AA OR AL-ANON-NOT BOTH. HOWEVER, MOST AA

CONVENTION COMMITTEES INVITE AL-ANON TO PARTICIPATE BY PLANNING THEIR OWN PROGRAM, AND THE COMMITTEE ARRANGES FOR FACILITIES

FOR THE AL-ANON MEETINGS. IF AA INVITES AL-ANON TO PARTICIPATE
IN THIS MATTER, ALL EXPENSES INVOLVED IN THE AL-ANON MEETINGS

ARE PAID FROM THE FUNDS OF THE AA CONVENTION COMMITTEE.

QUESTION: SHOULD AN AA CONVENTION COMMITTEE MAKE A CONTRI-BUTION TO AL-ANON FROM THE FINANCIAL PROFITS OF THE CONVENTION?

ANSWER: IN ACCORDANCE WITH THE SELF-SUPPORT TRADITIONS OF BOTH FELLOWSHIPS AND TO ABIDE BY THE CONCEPT OF 'CO-OPERATION BUT NOT AFFILIATION,' IT IS SUGGESTED THAT AA SHOULD NOT MAKE GIFTS OR CONTRIBUTIONS TO AL-ANON. BY THE SAME TOKEN AA SHOULD NOT ACCEPT CONTRIBUTIONS FROM AL-ANON.

WE THINK YOU WILL BE INTERESTED IN THE RESOLUTION OF GRATITUDE
TO THE FELLOWSHIP OF THE AL-ANON FAMILY GROUPS WHICH WAS

UNANIMOUSLY APPROVED BY THE 1969 GENERAL SERVICE CONFERENCE OF AA.

THE DELEGATES OF THIS, THE 19TH GENERAL SERVICE CONFERENCE OF ALCOHOLICS ANONYMOUS, MEETING IN OFFICAL SESSION IN NEW YORK, CITY, THIS 25TH DAY OF APRIL, 1969, DO HEREBY DECLARE:

WHEREAS, IT IS THE DESIRE OF THIS CONFERENCE TO CONFIRM THE RELATIONSHIP BETWEEN ALCOHOLICS ANONYMOUS AND THE AL-ANON FAMILY GROUPS, AND WHEREAS, IT IS THE FURTHER DESIRE OF THIS CONFERENCE TO ACKNOWLEDGE AA'S DEBT OF GRATITUDE TO THE AL-ANON FAMILY GROUPS, THEREFORE, BE IT RESOLVED, THAT ALCOHOLICS ANONYMOUS RECOGNIZES THE SPECIAL RELATIONSHIP WHICH IT ENJOYS WITH THE AL-ANON FAMILY GROUPS, A SEPARATE BUT SIMILAR FELLOWSHIP. AND BE IT FURTHER RESOLVED THAT ALCOHOLICS ANONYMOUS WISHES TO RECOGNIZE, AND HEREBY DOES RECOGNEZE, THE GREAT CONTRIBUTION WHICH THE AL-ANON FAMILY GROUPS HAVE MADE AND ARE MAKING, IN ASSISTING THE FAMILIES OF ALCOHOLICS EVERYWHERE."
